## PUBLIC NOTICE

### Request for SMME Company documents for Rustenburg Local Municipality

This notice serves to inform Service Providers within the Rustenburg Jurisdiction to update their details on National Treasury Central Supplier Database, this is an extension of the Preferential Procurement Policy Framework of 2017 which came into effect on the 1<sup>st</sup> April 2017, Specifically on Pre-qualification criteria for preferential procurement and sub-contracting on the following:

- a tenderer having a stipulated minimum B-BBEE status level of contributor;
- an EME or QSE;
- a tenderer subcontracting a minimum of 30% to-
  - an EME or QSE which is at least 51% owned by black people;
  - an EME or QSE which is at least 51% owned by black people who are youth;
  - an EME or QSE which is at least 51% owned by black people who are women;
  - an EME or QSE which is at least 51% owned by black people with disabilities;
  - an EME or QSE which is 51% owned by black people living in rural or underdeveloped areas or townships;
  - a cooperative which is at least 51% owned by black people;
  - an EME or QSE which is at least 51% owned by black people who are military veterans"

Service Providers are urged to update their details on Central Supplier Database to enable the system to filter it in accordance with the above-mentioned criteria.

To qualify as a sub-contractor or supplier, the following requirements must be met:

- Registration with the CIDB in the minimum class of Civil Engineering (CE) registration and General Building(GB) & Electrical
  - Submit a Tax Clearance certificate
  - Submit a certificate incorporation (if a company)
  - Submit a joint venture agreement (if a Joint Venture)
  - Submit copy of rates and taxes (for both Directors of company and company)
  - Company profiles
  - Suppliers of Printing, promotional material, media buying, branding, stand design & bookings for exhibitions, videography, photography, events management and equipment hire, sound hire, transport hire and translation services also need to supply the above required documents where applicable
- It is the responsibility of the Contractors/Service providers to ensure that they are tax compliant with SARS at any given time as verification will done through the Central Supplier Database. Those who are not in the Central Supplier Database are more than welcome to come to room 103, first floor, Missionary Mpheni House, Rustenburg Local Municipality offices to be assisted.
