Money Market SCAMS

Rustenburg/ Boitekong – In a ruthless scheme to rob people of cash paid over to family members and friends, three suspects were arrested in Boitekong after exceptional detective work.

An African female and two African males were arrested and appeared before the Rustenburg Magistrates' Court on Monday, 19 June, where they were released on R500 bail each. The case has been postponed to Tuesday, 1 August.

Members of the community using the Shoprite Money Market facility were stunned to realize that after using the facility in Boitekong, to send money to relatives, the relatives or friends never received the money, as it had already been withdrawn.

Frustrated members of the community reported various cases in Rustenburg, Mogwase and Boitekong.

An intensive investigation led to the arrest of an employee of Shoprite in the Boitekong Mall. The African woman would access details of the unique Money Market "M" number and pin number allocated for the transaction.

"She would then allegedly send the details to her partners in crime, who would make the withdrawals," Elsabé Augoustides, police spokesperson, said.

Arrested for illegal firearm

Rustenburg/ Phokeng – A 41-year old man was arrested on Tuesday, 25 July, for the possession of an illegal firearm.

Information was obtained that the man was in possession of the firearm near Bafokeng's Rasimone mine close to Phokeng. "When the Police arrived, the man was not in possession of the firearm. After being escorted to his home, the firearm and ammunition was discovered," sgt Gabaiphiwe Kgatlha, police spokesperson, said.

The suspect appeared before the Bafokeng Magistrates' Court in Tlhabane on Thursday, 27 July. Investigations continue.



Protestors arrested

Rustenburg/ Brits – The Brits Police arrested 19 suspects aged between 20 and 71, for public violence through the illegal blocking of roads (the N4, R556 and R104) and for the damage of property that occurred between Monday 17 July and Wednesday 19 July in Bapong village near Mooi Nooi. The suspects appeared before the Brits Magistrates' Court on 20 July and 21 July respectively, where they were all granted bail of R500. According to sgt. Talane, police spokesperson, the suspects' cases were remanded to 22 and 28 August. The illegal activities caused great frustration to members of the community as well as businesses, as important roads could not be used. This in the same week as Mandela day... The Brits cluster commander major general Joel Mosimanegape forewarns members of the community that in any activity where a member of the community is found engaged in relation to criminality or that amounts to unlawfulness, the Police will exercise their powers to bring about order and stability.
