# Our Safety in Jeopardy

## Letter to the Editor

**Dear Readers,**

I have written this letter with the utmost concern for the safety of our community members, in and around the Rustenburg area.

The Emergency Unit at the Job Shimankana Tabane Hospital (JSE) has closed their doors a couple of times in recent weeks, as they "do not have the capacity to accommodate all emergency situations at all times".

Basically, if one Bojanala Bus (which can accommodate up to 68 passengers) crashes, not even a half of them can be accommodated at the JSE.

I have spoken to the Clinical Manager at the Casualty Unit, and according to him, the unit was "overloaded". He showed patients needing urgent attention away to Moses Kotane Hospital, Swartruggens Hospital and Koster Hospital – all approximately 60 kilometres away. That means that when an ambulance brings a patient requiring urgent attention, he/she must wait for about an hour before receiving medical attention. What's more, that means that the ambulance transporting the patient will waste about 2-3 hours... 1 less ambulance in Rustenburg – and we do not have that many ambulances.

The question remains: We have 5

emergency services in and around Rustenburg which includes ER24, Netcare911, Local Provincial Services (Rustenburg), Sun City Emergency Services as well as surrounding Provincial Emergency Services. How can just one Public Hospital cater for all these emergency services?

So JSE refers patients to the surrounding, smaller hospitals with lower ratings... How can this be possible??? I have spoken to numerous emergency personnel, and everyone basically stresses the same issue: "We need another hospital in Rustenburg". Is that really the answer or should JSE grow in capacity?
