

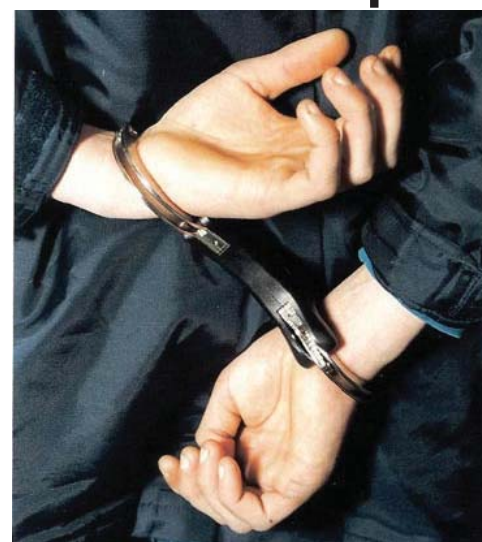

2 Arrested for Rape



Taug – Police arrested two suspects after two cases of rape were reported. The two men are being suspected of raping two women in two separate incidents. The first incident took place at Magogong village at about 19h00; it is alleged that a 15-year-old minor was raped. The victim was allegedly on her way to visit a friend when the rape occurred. According to the victim, the suspect grabbed and dragged her to the nearest playground where she was strangled before she was raped. The 21-year-old suspect has since been arrested and appeared briefly before the Taung Magistrate's Court on 5 September. In another case in the same area, a 32-year-old woman was raped by a 22-year-old man. The victim was drinking with friends in a tavern. She went to use the toilet and the alleged suspect followed her and raped her. The rape incident took place at about 00h47 after midnight. The suspect also appeared before the Taung Magistrate's Court Monday 05 September 2011.

Man burnt to death by angry mob

Rustenburg – Police in Boitekong are investigating two cases of murder and arson. On Sunday, they arrested a 32-year-old man in connection with the murder of an 18-year-old male victim, who was killed over the weekend. The Boitekong community members allege that there was another suspect who was also involved in the murder of the 18-year-old victim. The Community then took it upon themselves to locate the alleged second suspected who escaped on foot to a place between Sunrise Park and Ramotsana – which is known as the "New Stand". He ran into the caravan [which is the house of the arrested suspect] where he locked himself inside. The angry mob attempted to force entry and when they failed, they set the caravan alight with the second suspect inside. When the Police were called to the caravan, it was already in ashes. On questioning the suspect arrested, the Police could not attain the identity of the deceased. According to the man arrested, he could not identify him as they are not close and he (second suspect according to the community) was only his part-time garden boy and he did not know him by name. Three cases have been opened – one of arson and two of murder.

1. 4. All bids will be evaluated in accordance with the Supply Chain Policy of the Rustenburg Local Municipality, PPPFA and other related legislations. Bids will remain valid for 90 days.
5. An updated record of payment of rates, taxes and services to the relevant municipality must be attached. Failure to do so will invalidate the bid submitted.
6. The lowest or any bid will not be necessarily accepted and the municipality reserves the right to accept the whole or part of any bid. The municipality reserves the right to increase or decrease quantities as indicated in the technical specifications.
