Closing of Comrades 2012 Early Bird Entries

Runners, take heed! The early bird catches the worm and gets a discounted entry into the Comrades 2012 field! In the spirit of practiveness, the Comrades Marathon Association (CMA) has urged all South African runners who have not yet entered the 2012 edition of the Comrades Marathon, to take advantage of the 'Early Bird' entry fee by close of business today.

As of 1 September 2011 to date, the 'Early Bird' fee is a discounted rate of R270 compared to the regular price of R300 which is only applicable to South African runners. Entry fees for athletes from the rest of Africa are R500 and the cost to international runners is \$US180.

Entries for Comrades 2012 have been coming in hard and fast! As of this Friday, 30 September 2011, the entry barometer stands at 7907.

The entry process for the 87th staging of South Africa's most famous road-running fixture opened on Spring Day, 1 September and will close on Wednesday, 30 November 2011.

The entry period is three months long and open to all athletes, irrespective of them being veteran or novice Comrades runners. Entries have been limited to a maximum of

18000 runners and no extensions will be granted.

Entries close strictly on 30 November 2011 or as soon as 18,000 entries have been received (e.g. if 18 000 entries are received by the 10 November 2011, then no further entries will be accepted).

Qualifying for the 2012 Comrades Marathon is applicable as of 29 May 2011 until 4 May 2012. Runners have been urged to take careful note of the entry criteria. For more details, please visit the official Comrades website, www.comrades.com or call Comrades Marathon House on 033 897 8650.

CMA General Manager Gary Boshoff said, 'While the Ultimate Human Race has been attracting record numbers of international competitors over the years, we at the CMA owe it to our South African runners who have made the race the icon that it is today. The 'Early Bird' entry fee is one little way of us conveying a huge Thank You to the Rainbow Nation.'

Gary added, 'In keeping with our Guinness World Record endorsement, we look forward to hosting another awesome running of the 2012 race'.
