4. All bids will be evaluated in accordance with the Supply Chain Policy of the Rustenburg Local Municipality, PPPFA and other related legislations. Bids will remain valid for 90 days.
5. An update record of payment of rates, taxes and services to the relevant municipality must be attached. Failure to do so will invalidate the bid submitted.
6. The lowest or any bid will not be necessarily accepted and the municipality reserves the right to accept the whole or part of any bid. The municipality reserves the right to increase or decrease quantities as indicated in the technical specifications.
