ARE YOU GEARED FOR NEW PROCURMENT REGULATIONS A MUST from 7 December 2011

Companies that wish to conduct business with government will be required to submit their valid BEE Certificates obtained from an Accredited Verification Agency or Registered Auditors approved by the IRBA.

Companies with annual revenue of R 5 million or less must get an Exempted Micro-Enterprise Certificate from a registered Auditor or Accounting Officer confirming their annual turnover.
