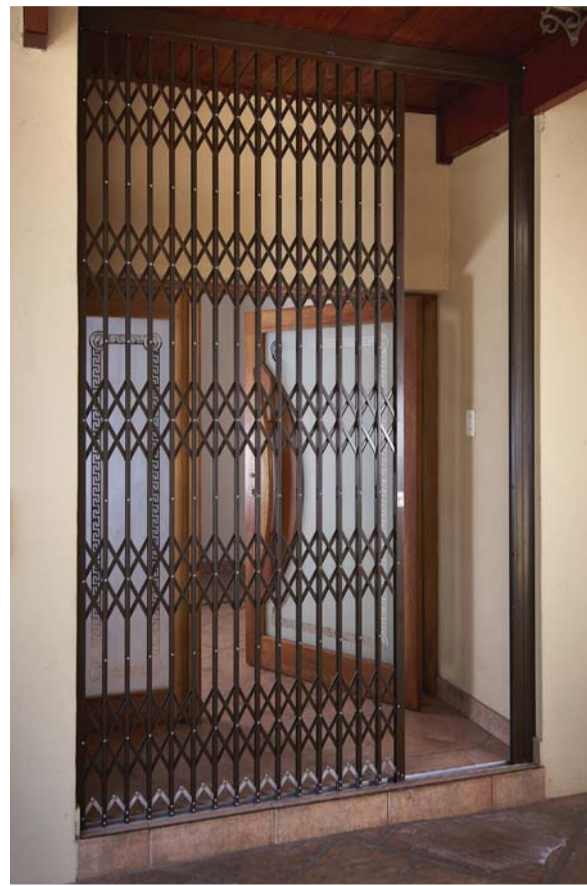

NOTIFICATION IN TERMS OF SECTION 79(18)(b) of the LOCAL GOVERNMENT ORDINANCE, ORDINANCE 17 OF 1939, AS WELL AS SECTION 14 OF THE LOCAL GOVERNMENT MUNICIPAL FINANCE MANAGEMENT ACT 56 OF 2003 and its Regulations, including but not limited to the RUSTENBURG LAND DISPOSAL POLICY 2015-2017; IN RESPECT OF ERVEN IN GEELHOUTPARK EXT 6, RUSTENBURG EXT 7 & RUSTENBURG EXT 12.

Council had, per items 282 and 283 on 2 December 2016 resolved:-

1. That the report on the Disposal of residential 1 stands, be noted;
2. That the remaining stands be offered for sale out of hand at the upset price (market-related valuation) on a first come first served basis;
3. That the intention to dispose of the remaining stands be advertised in terms of Section 79 of the Local Government Ordinance 17 of 1939;
4. That the pre-emptive condition: "that a dwelling house be constructed within 3 years from the date of transfer of the property", be imposed;
5. That the enforcement of building regulations be intensified;
6. That a progress report be submitted to Council on a quarterly basis.
