

RHINO POACHING ACCUSED IN COURT

Rustenburg/ Sun City – Rhino poaching accused Arnelo Mhlanga (39) appeared before the Mogwase Magistrates’ Court facing charges of the possession of rhino horns and the illegal possession of firearms and ammunition.

Mhlanga was arrested on Monday 2 July between Sun City and Madikwe after being spotted leaving the Pilanesberg Game Reserve with two other suspects in a Mazda bakkie.

“Rangers at the park gave chase. The suspects lost control of their vehicle which crashed into a large tree, next to the road in Silverkrans,” said lieutenant general Baile Motswenyane. The police were summoned and one of the suspects was arrested. Two managed to escape.

Six rhino horns, an illegal firearm and an axe were confiscated.

In the meantime, the suspect is linked to another rhino poaching incident on 30 June at the Pilanesberg Game Reserve.

The case was postponed to Monday 16 July and the suspect remains in custody.

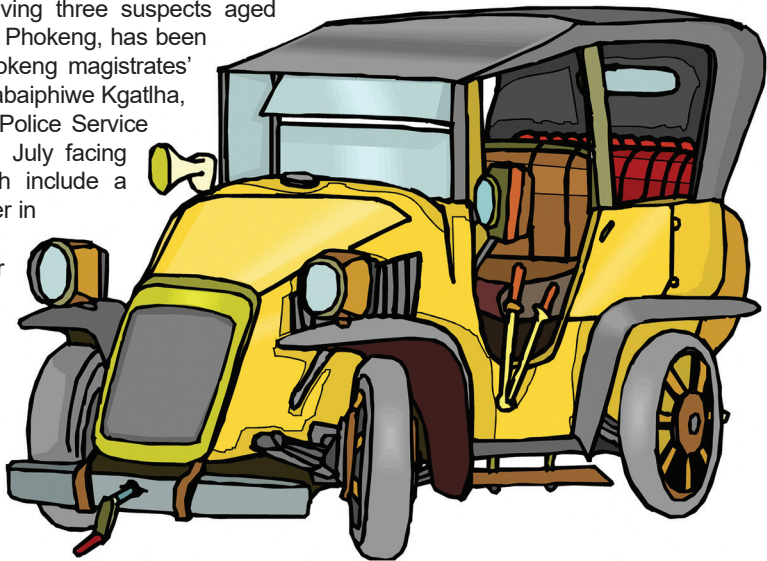

Car thieves arrested in Phokeng

Rustenburg/ Phokeng – The case involving three suspects aged between 24 and 59 arrested for car theft in Phokeng, has been postponed to Monday 16 July by the Bafokeng magistrates’ court in Tlhabane, according to sergeant Gabaiphiwe Kgathla, police spokesperson of the South African Police Service (SAPS). The trio appeared on Monday 9 July facing charges of theft of motor vehicles which include a Nissan 1400, Isuzu Bakkie and Ford Ranger in Freedom Park.

A statement issued by the office of the cluster commander major general Arthur Adams stated that the suspects were using a white Toyota Quantum in the execution of their criminal activities. The Quantum was later set alight by angry community members.

The suspects’ modus operandi involved pushing vehicles from different yards into the streets after which they used sensors to check if the vehicles were fitted with tracking devices.

Ná hoe lank moet ek 'n eis indien?

Indien die identiteit van die oortrede bestuurder of eienaar van die voertuig bekend is, moet die eis binne drie jaar vavaf die datum van die ongeluk ingedien word. Dit is nie van toepassing by die eis van 'n minderjarige nie. Indien die identiteit van die persoon onbekend is, moet die eis binne twee jaar ingedien word.

Waarvoor kan ek eis?

- 'n Eis kan uit die volgende bestaan:
- Gelede en toekomstige hospital-en mediese uitgawes
 - Gelede en toekomstige verlies van inkomste
 - Algemene skadevergoeding vir pyn , lyding en verlies van lewensgenieting.
 - Gelede en toekomstige verlies van onderhoud in die geval van die afhanklike van 'n oorlede slagoffer
 - Begrafnisuutgawes
