The Department of Rural, Environment and Agricultural Development, and National Department of Agriculture, Forestry and Fisheries calls for organized Agriculture, Farmers (Small holder and Commercial), Entrepreneurs, Previously Disadvantaged Individuals (Youth, Women and People Living with Disabilities), Institutions (Traditional Leaders, School, Churches and etc.) and Cooperatives to apply for funding for 2019/20 financial year based on the four Departmental prioritized Programmes namely:

**NB: Funding consideration is based on commodity value chain (Farm-to-Fork). Applicants may choose to be supported with one and/or combination of the following:**

1. On and off farm infrastructure and production inputs
2. Farmer Training (Skill development & Capacity Building)
3. Enterprise Business Development, Marketing & Trade
4. Agro – Processing Business Development Support
5. Land Care
6. Special Programme
7. Primary Animal Health Care

**Applicants will have to demonstrate appetite to farm and/or run a Profitable Business. Proof of access to land and legislative obligations must be demonstrated.**

No late, faxed or emailed applications will be accepted. Applicants will be given reference number upon receipt of the application. The Department reserves the right to consider any application. Successful applicants will be required to enter into a funding agreement with the Department in line with government prescripts.
