Rustenburg – Endurance athletes are challenged to compete in both the Keystone Milling Mountain Race on Saturday 1 September as well as the Cycle Zone Mountain Bike Challenge on Sunday 2 September, to qualify for the Kgaswane Extreme Challenge.

To qualify for this unique medal, athletes must complete both the running race on Saturday, either the 10km or 25km, as well as the mountain bike event on Sunday, either the 35km or 60km.

This challenge was held for the first time in 2017, but nobody managed to finish both long events, the 25km running as well as the 60km cycling. Will this year be the first? Both the running and cycling starts and finishes at the Kloof Resort at 07:00 and follow remote, traffic free trails and roads in the magnificent Kgaswane reserve. Please note: the running is on hard surfaces, not trail running; but the mountain makes it a serious challenge.

The running event will have three distances, a 25km, 10km as well as a 5km fun run. The mountain bike challenge will have three distances: 60km, 35km and 15km. There will also be a 'kiddies ride' of 5km which will be free of charge.
