Notice is hereby given in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) and the National Water Act, 1998 (Act No 36 of 1998). The intention of the Applicant (Rooderand Chrome (Pty) Ltd: Rooderand Chrome Mine) is to apply for a water use licence for the existing opencast mining operations on the properties as identified. Location: The proposed location of the proposed project is on the Remaining extend and portion 2 of the Farm Rooderand 46 JQ Moses Kotane Local Municipality within the Bojanala District Municipality in the North West Province.

The development constitutes the following: Operation of opencast mining sections, a crushing and screening plant and supporting infrastructure.

Environmental Process: Rooderand Chrome has appointed Prescali Environmental Consultants (Pty) Ltd, as independent environmental consultants, to draft the IWWMP and assist with public participation as required in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) as well as other related environmental legislative requirements.
