# SA mourns Edna Molewa

With the death of environmental  
affairs minister Edna Molewa,  
South Africa and the international  
community lost a visionary leader  
who elevated the portfolio to global  
stature and who was instrumental in  
the design and implementation of the  
national environmental policy.  
Molewa was a South African  
politician and member of the African  
National Congress. She became the  
minister of Water and Environmental  
Affairs of South Africa on 31 October  
2010, as part of a cabinet reshuffle  
by the then president Jacob Zuma.  
On 25 May 2014 her ministry has  
been divided and she was appointed

minister of Environmental Affairs.  
Prior to her death, Molewa was  
studying towards a bachelor's degree  
in communications through the  
University of South Africa.  
During her tenure, Molewa was  
involved in South Africa's liberation  
movement from 1976 through 1990.  
During that time, she was a  
member of various activist  
and regional economic  
development organisations.  
Molewa worked very hard  
to advance the integrated  
strategic management of  
rhino through a variety of  
conservation-minded efforts.

A memorial service for Molewa  
was held at the Christian Revival  
Church in Silverlakes, Pretoria, on 27  
September 2018.
