The late Gareth Roberts.

Rustenburg – Gareth Roberts (23) died a hero. He paid the ultimate price when he laid down his life to save the life of a stranger, and Rustenburg will honour and remember him for this sacrifice.

Gareth died following an armed robbery and botched hijacking, as reported in the *Platinum Weekly* issue of 2 February 2018.

Incredible Connection in the Waterfall Mall was robbed at gunpoint. Six suspects fled the scene, three in a getaway vehicle and three on foot. The mall's security guards gave chase, and when the three suspects on foot reached the intersection opposite McDonald's and BP garage at the mall, they decided to hijack a vehicle.

Gareth and his mother witnessed the criminals about to hijack a Nissan NP200 bakkie – a man, his wife and child still inside.

Gareth risked his life for the family. He rushed over to help and was shot twice in the chest.

Thanks to his sacrifice, the family escaped unscathed.

Gareth sadly passed away in hospital later that day.

To honour this legendary young man, the Rustenburg Local Municipality

started the process to rename Howick Avenue in Rustenburg to Gareth Roberts Avenue.

The new name was unveiled on 28 February 2019. Gareth's family, members of RLM and the community attended the unveiling.

Pastor Gopolang Sekano of the Rustenburg's Pastors Forum opened the ceremony with prayer and read a piece from Matthews 22 - loving thy neighbour. Agapé Gemeente Pastor Dawie van Schoor read from Corinthians 13 and said that Gareth showed the world what the meaning of love truly is.

Mayor of Rustenburg Mpho Khunou said: "It is infuriating that the people who killed Gareth has not been brought to justice yet. Gareth stood up for what he believed in and with this renaming, we want to show criminals that they will not take our city. As a community we must stand together in the fight against crime."

Gareth will always be a hero to the city of Rustenburg. He saw an injustice and stepped up to the plate. May everyone remember what this young man did every time they drive down Gareth Roberts Avenue.
