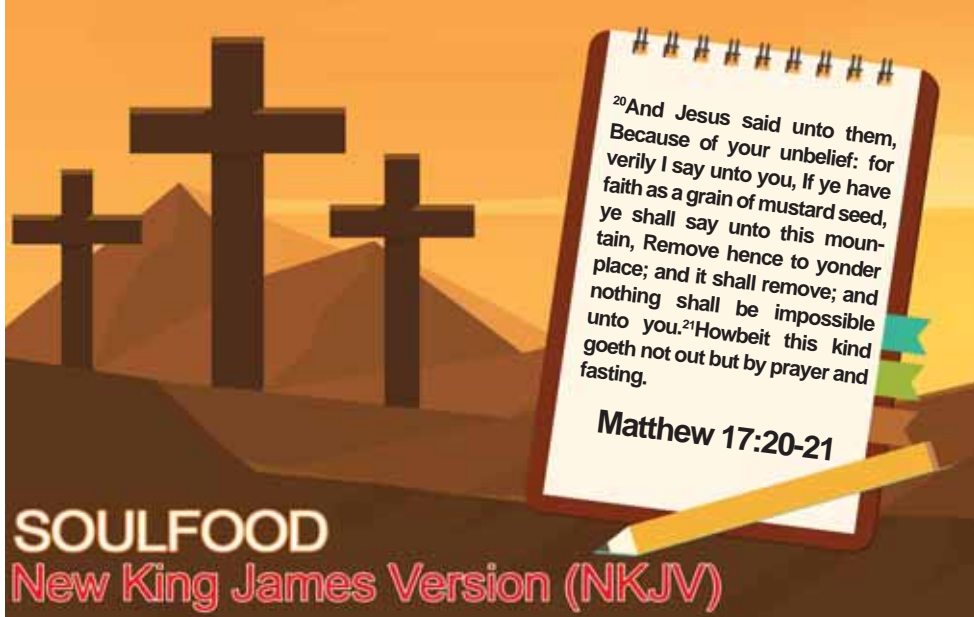
Zero-tolerance for police corruption

Rustenburg/ Phokeng – It was a hive of
activity at the Phokeng Conference Centre
on Wednesday 13 March as hundreds
of community members turned up for a
stakeholder engagement session, hosted
by the office of the Directorate for Priority
Crime Investigation (DPCI) in partnership
with the Department of Civilian Secretariat
for Police Services (CSPS).
The purpose of the gathering was to urge
community members to come forward and
report incidents of corrupt activities within
law enforcement structures such as the
police and the Hawks.
DPCI judge Frans Kgomo, North West
premier Job Mokgoro as well as the
provincial member of the executive

committee (MEC) for Public Safety Mpho
Motlhabane were among the guests who
attended the event.
Benjamin Ntuli from the CSPS explained
the mandate of the DPCI and how it fits
into crime fighting initiatives. “DPCI is key
because it makes sure that corruption is
uprooted at all levels of our structures.
Community Police Forums are also vital in
ensuring that crime is reduced,” said Ntuli.
“We serve as an advisory to the minister of
police to make sure that there is inclusivity
in the police,” he added.
Major general Arthur Adams assured the
DPCI that police provincial commissioners
would work hand-in-glove with them to
uproot corruption.
