Zinniaville Secondary School's u/16 boys put up a brave effort but finished as runners-up to Hoër Tegniese Skool Rustenburg in the final.

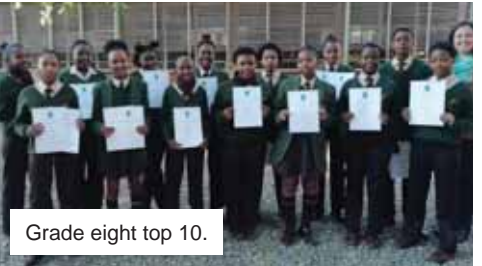
