FIRE SEASON

Rustenburg - The summer rainfall regions, the long dry winters and dry grass make veldfires unavoidable especially in Rustenburg.

All that is needed for a veldfire to occur is a source of ignition. High air temperatures, low relative humidity and high wind speeds associated with dry vegetation increases the difficulty of extinguishing a veldfire once it has started.

Veldfires start small but the rate of spread and heat intensity depends on the weather, the terrain and the condition of the available fuel. The more intense the veldfire the more difficult it is to control.

Veldfires can often engulf properties and destroy entire house in mere moments.

Window glass can fail relatively easily during a fire, allowing high levels of heat to enter the interior of the house often igniting flammable furnishings like curtains.

Taking a few easy precautions could substantially reduce the risk of fire on your property.

Here are a few tips to keep you safe:

- Properties situated next to dense vegetation or on ridges are at higher risk. All buildings are at risk when situated close to fire-prone vegetation.
- You need easy access into the roof to check for cinders that have found their way in.
- Avoid complicated rooflines where embers can lodge.
- Clean gutters as they collect leaves and other flammable
- Timber should not be used at ground level and, if it is, it should be treated to be fire-resistant.
- Avoid wood trellises on the exposed sides of buildings. Metal screens to a fireplace prevent sparks blowing down the
- Wooden and thatched roofs are the most vulnerable.
- Radiant heat and flame contact can be prevented by landscaping your garden before the fire season.
- Watch for spot fires very carefully during a veldfire.
- Small fires can easily be extinguished if caught early.
- Sprinkler systems can useful to soak the most vulnerable parts of the house.
- A well-maintained garden would reduce fire intensity.

Preventing fires on a farm

- Remove tree branches that could cause a power line short circuit.
- Restrict the use of farm machinery on days when the fire danger is high.
- Take great care when using welding, cutting and grinding equipment.
- Establish fire breaks between your land and a road or railway.
- Store fuels in a separate building away from houses.
- Adopt no-smoking policies around high hazard areas such as fuel stores.
- Adopt safety standards for burning rubbish, braai fires or disposing of hot ash.
- Make sure all fires are extinguished properly before leaving
- Have your own well-maintained firefighting equipment on the
- Fix spark guards to chimneys and exhausts.
- Check electrical installations regularly.
- Loss of farm animals can be prevented by preparing and maintaining fuel-reduced areas onto which stock can be moved and held during a fire.
- Plan to use fallow fields, well grazed fields or areas with bare around
- Where possible have shade and water available for valuable especially breeding stock.
- Protect your fodder reserves.
