Notice is hereby given to all the affected community members, business users and outdoor advertising media companies of the reviewed Rustenburg Local Municipality Outdoor Advertising By-Law of 2019. In order to implement this By-Law, all existing outdoor advertisements that are currently displayed across the municipal area of jurisdiction must be audited, registered and aligned with the applicable provisions of this By-Law.

It is therefore incumbent on all the outdoor advertising companies, individual owners of outdoor signs and government departments to approach the municipality to make the necessary applications for the respective signs to be aligned to the By-Law.

This exercise must be complied with from the date of publication of this Notice until Thursday 31 October 2019. Any other outdoor sign that is not registered or approved in terms of these arrangements and By-Law after that date shall be deemed to be illegal and the enforcement provisions shall apply.
