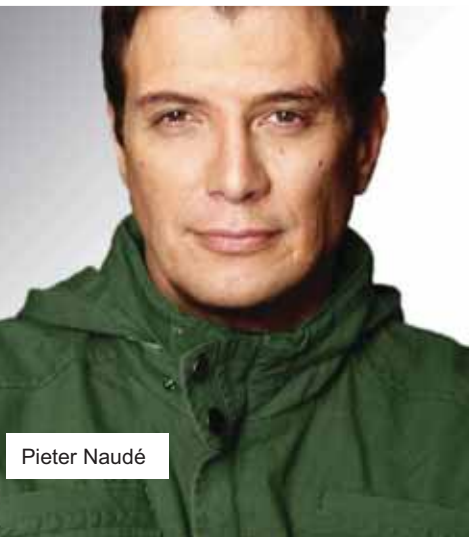

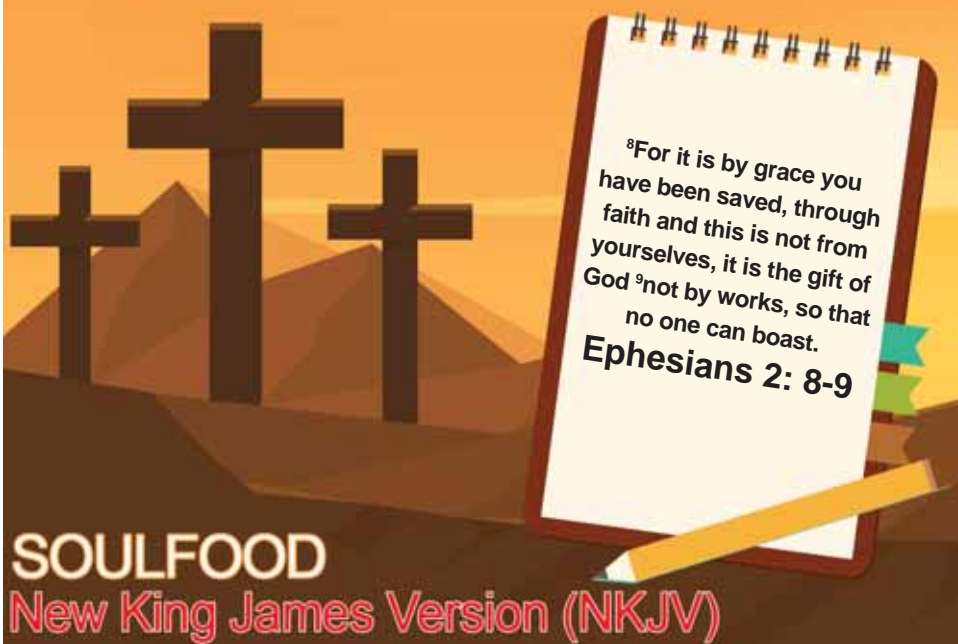

KIDNAPPING CASES SKYROCKET WITH 139%

SA – A stark reality... 16 people are being kidnapped or abducted in South Africa daily. This represents an alarming increase in abduction crimes when compared to figures recorded by the police during previous years. Although the kidnappings have been more concentrated in Gauteng and KwaZulu-Natal, there is a significant increase nationally from 2009 to 2019. This points to a bleak statistic which has been described as 'out of control' by some of the county's top investigators. According to the statistics, a total of 2,492 kidnapping cases were reported in South Africa between 2009 and 2010. The statistics reveal an increase with 5,693 cases being reported between 2018 and 2019. In Limpopo, 243 kidnappings were reported for 2018/2019, presenting a decrease from 300 recorded in 2017/2018. In Rustenburg, 29 kidnappings were reported between 2018 and 2019, representing an increase of 20.8%. Overall, the statistics show that kidnapping skyrocketed in South Africa by 139% in the last

decade. The police and organisations such as Pink Ladies had to double their efforts in an attempt to curb this crime wave. While in the past criminals used to target wealthy individuals, they have broadened their scope of victims and now prey on lower-income families as well as teenagers and children. There also appears to be a well-defined pattern of opportunistic abductions in which the criminals demand quick ransom payments, usually through e-wallets. Mike Bolhuis, a renowned private investigator, told news channel ENCA that in an effort to evade being detected, located and arrested, abductors have lately been demanding small amounts of money to ensure faster transactions. Notice is hereby given that a Water Use Licence Application (WULA)/General Authorisation (GA) Registration in terms of the National Water Act (NWA), 1998 (Act No. 36 of 1998, as amended) and the Regulations regarding Procedural Requirements for Water Use Licence Applications and Appeals, 2017, will be lodged with the Department of Human Settlements, Water and Sanitation (DHSWS).

Project Name: Gourmet Chickens Abattoir and Broiler Houses

Proponent: Gourmet Chickens (Pty) Ltd

Project & Property Description: The Water Use Licence Application (WULA) for the existing Gourmet Chickens abattoir, broiler houses and associated infrastructure is to integrate the historical, existing and the future water uses into a single Water Use Licence (WUL), on Portions 28, 74, 79, 94 and the Remaining Extent of Portion 84 of the Farm Wildebeesthoek 310 JR, within the City of Tshwane Metropolitan Municipality, in the Gauteng Province.

Location: The site, which is located on various Portions of the Farm Wildebeesthoek, is situated south of Multisands (Pty) Ltd. Flora RSA Nursery is located to the east of the most southern tip of the study area. The N4 Highway (Platinum Highway) runs in an east-west direction and traverses the site. Access to the northern section of the site can be gained via the bridge that is located across the N4 Highway. A dirt road, which stretches in a northern direction from the busy west-east stretching Road R513, gives access to the section of the facility that is located to the south of the N4 Freeway. The turn-off for the dirt road is located approximately 4km to the west of the Hornsnek/ R 513 T-Junction. A non-perennial watercourse cuts through the north-western section of the site and flows in a westerly direction. National Freshwater Ecosystem Priority Areas (NFEPA) wetlands are located to the north-west of the site. The Sand River flows in a northern direction, approximately 1.3km to the east of the study area. A Water Use Licence Application (WULA)/General Authorisation (GA) Registration in terms of the National Water Act (NWA), 1998 (Act No. 36 of 1998, as amended) and its associated Regulations will be submitted to the DHSWS.

The aforementioned proposed development triggers the following water uses in terms of the National Water Act (NWA), 1998 (Act No. 36 of 1998), as amended:

- Section 21 (a): Taking water from a water resource;
- Section 21 (b): Storing of water;
- Section 21 (c): Impeding or diverting the flow of water in a watercourse;
- Section 21 (e): Engaging in a controlled activity;
- Section 21 (f): Discharging of waste or water containing waste into a water resource through a pipe, canal, sewer, sea outfall or other conduit;
- Section 21 (g): Disposing of waste in a manner which may detrimentally impact on a water resource; and
- Section 21 (i): Altering the bed, banks, course or characteristics of a watercourse.
