**Rustenburg** – Hoërskool Rustenburg (RHS) het 2020 op 'n baie spesiale manier begin deur op Woensdag 15 Januarie drie Peperbasbome te plant.

Die Peperbasboom is 'n krities bedreigde boom. Omdat die bas, blare en wortels verskeie siektes kan genees, word hulle gereeld gestroop wat daartoe lei dat die bome dood gaan – en so het dié bome op die rooi lys beland.

Nie net het hul 'n bydrae gemaak tot die oorlewing van die boom nie, maar elke boom is 'n simbool van iets wat na aan hul harte lê. Die simboliek van die drie bome is onderskeidelik:

1. Meneer Hennie Pieterse as nuwe skoolhoof van RHS.
2. Meneer Danie Greyling as uittredende waarnemende skoolhoof.
3. Rustieraad as leiers van 2020.
