# INTIMATE PARTNER VIOLENCE

**Rustenburg** – Intimate partner violence (IPV) is domestic violence by a current or former spouse or partner in an intimate relationship. IPV comes in many forms such as physical, verbal, emotional, economic and sexual abuse and can vary in how often it happens and how severe it is. The abuse can range from one episode of violence that could have a lasting impact to chronic and severe episodes that can span over multiple years. Persons with certain risk factors are more likely to become perpetrators or victims of intimate IPV. Those risk factors contribute to IPV but might not be direct causes. Understanding these multi-level factors can help identify various opportunities for prevention.

**What are the common risk factors for intimate partner violence?**

- Low self-esteem.
- Low income.
- Low academic achievement.
- Young age.

- Aggressive or delinquent behaviour as a youth.
- Heavy alcohol and drug use.
- Depression.
- Anger and hostility.

# FOOT-AND-MOUTH OUTBREAK: SA RESUMES EXPORTS

**South Africa** – The county is winning the battle to contain a foot-and-mouth (FMD) outbreak after placing a ban on trading livestock, in November 2019. On Monday 17 February, Agriculture, Land Reform and Rural Development minister Thoko Didiza announced that the ban is now officially lifted. In the 15 November 2019 issue of *Platinum Weekly*, it was reported that the export of cloven-hoofed animals and related fresh products to Zimbabwe had been stopped following an outbreak of the disease in the Molemole district of Limpopo. Exports to eSwatini were also halted when reports of the outbreak reached the country. The ban was a necessary measure by the department to contain the disease and prevent it from spreading to other parts of the country. The good news is that the country can now resume its trade activities with the two countries, a clear sign that efforts by the department to contain the disease are bearing fruit. Said Didiza: "In our approach, we had to balance amongst a few variables, the risks and opportunity costs relating to the possible spread of the disease, economic losses to the entire country and financial

losses to stakeholders." The ministers said auctions, which had also been banned, will now also resume under stringent conditions. "All livestock agents must be registered with the Agricultural Produce Agents Council," said Didiza.



The ban on the trade of livestock has now been lifted.
