FAMILIES OF MURDER VICTIMS SEEK CLOSURE

Proceedings at the Mogwase Magistrates' Court had to be delayed for two successive days in June after James Aaron Sithole, who is also due to stand trial for the murder of Joey and Anisha on 11

National Prosecuting Authority (NPA) spokesperson for the North West Henry Mamothame told Platinum Weekly that Sithole became ill as the magistrate was reading out the judgement of the 2014 murder of Amanda 'Mandie' Mey.

"On Monday 29 June, the court had to be adjourned at approximately 15:30 when the accused indicated he was not feeling well," Mamothame said. "The following day, judgement proceeded but was thrice interrupted after the accused fell ill again and vomited. The matter will be finalised on 20 July."

Joey and Anisha were kidnapped, raped and killed before their bodies were soaked in acid and burned beyond recognition.

Joey and Anisha had initially been reported missing on 10 December 2017. However, the gruesome crime only came to light six days later after the burned-out shell of the couple's vehicle was found in the Magaliesburg area.

Initially, eight individuals were arrested in connection with the murder of Joey and Anisha but three have since turned state witnesses. One state witness, Wilhelm Loubser, died in a motorcycle accident on 3 November 2018. During September 2019, Koos Strydom, the alleged 'mastermind' behind the murder of the three women, was found unconscious in his cell and was transported to hospital where he was declared braindead.

A dispute about the properties belonging to the three victims was reportedly at the centre of the killings. The families of all the victims have been following the two court proceedings and are hoping for closure.

Although the court accepted this due to the exceptional circumstances of the COVID-19 pandemic - the inquiry, which was initiated by the court itself, established that no one is above the law and that the accused needs to act responsibly going forward.

The trial date has been set for 1-3 December 2020. The NSPCA hopes that there will be no further delays as it took the prosecuting authority more than two years to decline to prosecute this case. Fortunately, the NSPCA was granted the powers to prosecute by the Constitutional Court as no person is above the law. We thank the AfriForum legal team.

HISTORY

The NSPCA was approached by Advocate Gerrie Nel to privately prosecute this case after the National Prosecuting Authority (NPA) declined to prosecute the case in 2017 - claiming that there was insufficient

In July 2014 the NSPCA obtained a warrant to inspect the animals on a farm in the North West province belonging to Thandi Modise - this was after receiving a tip-off that the animals on the property had been abandoned.

Modise's farm was littered with the carcasses of more than 50 pigs and other dead animals, such as geese, ducks, sheep and goats. More than 100 pigs, sheep, chickens and goats were found without food and water and the animals were found dead and dying. The animals were so desperately hungry, they were feeding off carcasses, cannibalising, and eating their newborn. It was one of the cruellest cases of animal abuse that the NSPCA had come across. These animals were denied basic minimum care and suffered neglect and starvation.
