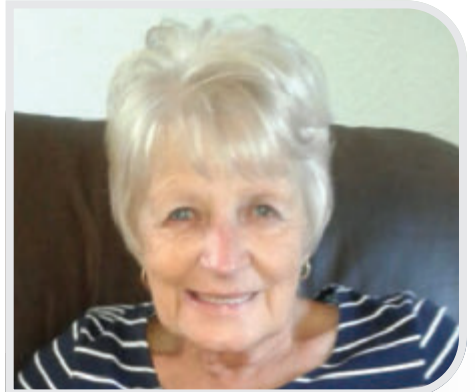

# Finansiële verligting vir Rustenburg DBV

## 4 NABBED FOR UNLICENSED FIREARM

**Rustenburg** – Four men appeared before the Rustenburg Magistrates' Court on Monday 12 July following their arrest for the possession of an unlicensed firearm. Francis Radebe, Mosoua Ntoi, Tholang Libitsa and Marelebohile Ramaria were remanded in police custody and are due to make their second appearance in the same court on Monday 19 July. "The men's court appearance stems from an

incident wherein members of Rustenburg Mounted Unit spotted a suspicious black Volkswagen Golf 4 while patrolling the streets on 8 July at around 12:00," police spokesperson colonel Adèle Myburgh explained. "The vehicle, which was parked in Boom Street, Rustenburg, was approached for a search. An unlicensed firearm was found hidden under a cloth on the rear seat."

# Possession of endangered pangolin lands man in court

**NW** – A 42-year-old man will have to give a detailed explanation to the Ganyesa Magistrates' Court of how he came into the possession of a pangolin. He was arrested for contravening the *National Environmental Management: Biodiversity Act, 2004 (NEMBA) (Act No. 10 of 2004)*.

The pangolin, of which South Africa has only one species, is considered endangered and therefore protected.

Onneile Monnanyane appeared before the court on Monday 12 July – two days after he was arrested for failing to produce the papers authorising him to be in possession of the pangolin. A multi-disciplinary team was directed after a community tip-off was received.

Teamwork by SAPS, K9 and Nature Conservation officials yielded the interception of Monnanyane in Tseng Village.

"He was granted R2,000 bail and his next court appearance will be on Friday 3 September 2021," police spokesperson colonel Adèle Myburgh said.

## Illegal dumping

**Koster** – A big pile of trash was dumped along the road between Buffelshoek and Rainbow Farms (Olifantsnek). Building materials, sand, broken brooms, cardboard boxes, vehicle number plates, and plastic bottles and bags are among the heap of rubbish dumped. The number plates are from the Free State while an auction board – with the address xx First Avenue, Olifantsnek – could be a tell-tale of the origin of the garbage. “Disposal of refuse on the side of the road is prohibited in terms of the municipal *Integrated Waste Management Plan (IWMP) of 2012* and the *National Environmental Management: Waste Act 58 of 2008* as well as the *North West provincial by-law*,” Kgetlengrivier Local Municipality spokesperson Sannah Magakgala said. For this sort of illegal dumping, you could be fined R2,500.

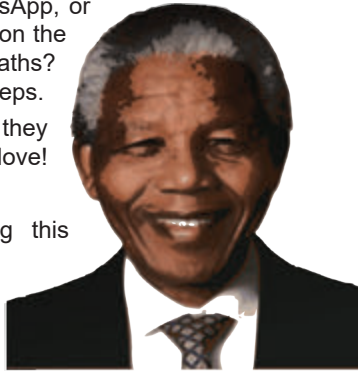

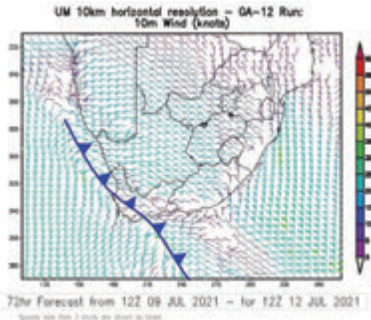


Wet, windy and cold conditions

**SA** – A Weather SA press release on Sunday 11 July stated that strong winds are expected this week across the Cape provinces and may result in property damage in some areas, following the arrival of a strong cold front (see figure).

- The public should take note that significant and widespread frost is expected over the western and central interior from Wednesday through to Friday.

Very cold conditions are also expected to set in with daytime temperatures plummeting to below 10°C over the western mountains of the Western Cape as well as the southern high ground of the Northern Cape. These are the areas where there is a possibility of snowfalls which may be as deep as 5 to 15 cm over the western mountains in the Western Cape Province, as well as on the southern high ground of the Northern Cape.

# ALOE IN THE MAGALIES



Aloes cover the Magaliesberg in their lovely colours.

**Rustenburg** – During the winter months, the Magaliesberg is covered in the beautiful colours of blooming aloes. There are five different types of aloe that can be found while roaming the footpaths of the mountain. Their flowers can be pale pink, yellow, orange or red. Because of all the nectar they produce, aloes tend to attract hummingbirds and beekeepers often take their hives to aloe fields. The sap from aloe also has many medicinal benefits and is often used to treat burn wound.

**This article will focus two types of aloe that grow in the Magaliesberg district.**

- *Aloe Davyana*

*Aloe Davyana* is a small stemless plant that usually blooms between June and July, they prefer full sun but also flourish underneath thorn trees. They can easily survive veld fires but do get damaged if the fires occur within their blooming season. You can still find plenty of them in the field, but their numbers are declining. Aloe is susceptible to the snout beetle that

come from the urban gardens and infect the plants in the field. Unfortunately, the only way to save them is through chemical control. They are not often found in gardens so if you see one in nature – please leave it there.

- *Aloe peglerae*

This small, stemless aloe is endemic to South Africa, where it only occurs in Gauteng and the North West Province. It is not easy to cultivate as the soil must be very well drained and it must be kept dry in winter. A sunny spot is essential. *Aloe peglerae* looks stunning in a garden especially in winter when there is little else in flower. However, it is listed as an endangered species on the extinction queue. This is primarily due to habitat destruction and illegal collecting. Because their numbers are declining rapidly, it is advised to rather not remove them from their natural habitat. It can be very tempting to take a few home with you when you see them flourishing in the wild but please don't remove them and opt for a nursery-grown aloe instead.

# Healthy rusks

She was taught to bake by his wonderful mother. “I was a terrible cook! Fortunately, she had loads of patience and every week we tried out a new recipe. She helped me every step of the way,” Charmaine said.

A few years later, a lady in Westonaria took Charmaine to a Vroue Landbou-Unie (VLU) meeting. She eventually joined the team and with great enthusiasm participated in their branch competitions. Here she learned all the tricks of the baking trade as they aim to keep the modern woman informed.

Charmaine added: “My husband passed away a few years ago and I remarried. My new husband loves rusks and I love baking it for him. I hope you find delight in this recipe.”

## Ingredients

- 500g margarine
- 300ml brown sugar
- 1kg self-raising flour
- 15ml baking powder
- 15 ml salt
- 750 ml All Bran flakes
- 200ml bran
- 200ml sunflower seeds
- 500 ml buttermilk
- 2 eggs
- 125g pitted dates

## Instructions

- Preheat the oven to 180°C.
- Spray the pan with Spray and Cook.
- Soften the dates in hot water.
- Melt the butter and brown sugar over a low heat and add the softened dates.
- Sift the self-raising flour, salt and baking powder together, and then add the bran, sunflower seeds and All Bran flakes.
- Mix the eggs and buttermilk together and add to the butter mixture.
- Layer the pan with 1 soup spoon of white sauce.
- Mix everything together and push firmly into the pan.
- Bake for 45 to 60 minutes.
- Once it is cool, place it back in the oven and let it dry out for another 4 hours on 100°C.

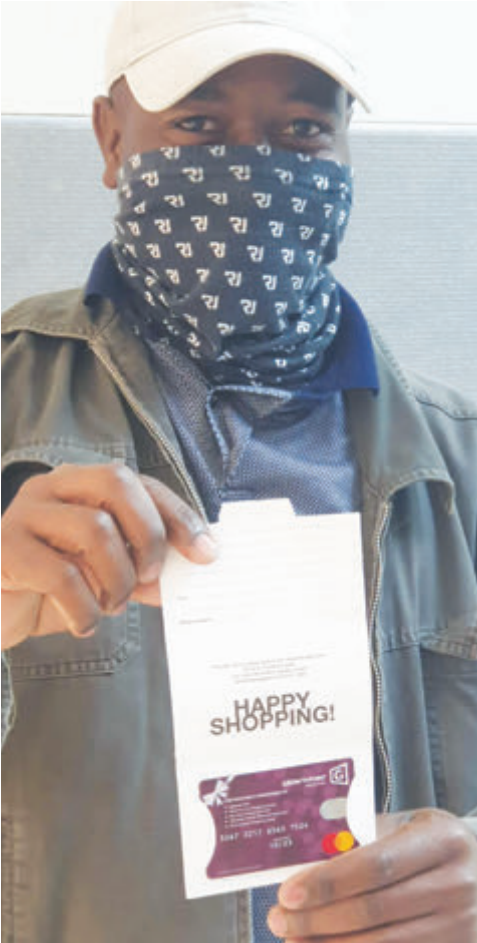

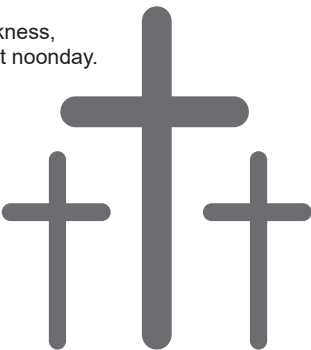
