# Young family shattered after N4 murder

was brutally shot in front of his wife and their oneyear-old daughter on the N4 on Saturday 7 May.

The trio lived in Brits but visited Rustenburg almost every weekend to spend time with their close-knit family. As usual they left Rustenburg on Saturday evening after their visit so that they can be in church on Sunday where Juandré played drums for their church band.

As they were traveling an object in the road damaged their tyre. Juandré knew of the risks of stopping on the N4, so he kept going a bit further until he found a spot that felt safe to stop

While busy changing the tyre three assailants attacked him from behind. He begged them to take everything they want and pleaded with them not hurt his family. They ransacked the car for items including a cellphone and then shot him in the head

The killers then turned to his wife Johanette Kidson who was holding their young daughter and then attempted to take the baby from her. She fought with everything she had to keep her daughter safe and in the process was shot in the shoulder. Johanette somehow manged to escape and ran into the field next to the road where she hid. A tow truck who was in the area heard the shots and went out to investigate and found Johanette with her daughter. The little girl was unharmed.

Johanette was rushed to hospital for her gunshot wound but has since been released and is staying with her family in-law.

Police spokesperson captain Aafie Botma confirmed that an attempted murder and murder

investigation. No arrests have been made yet.

These people came with one goal - to kill My brother cooperated with the attackers; he didn't care about anything else more than keeping his family safe. The killers got what they wanted, they could have just left but they still killed him and shot his wife." Marco Kidson, Juandré's vounger brother said in an interview with Platinum Weekly.

Marco also has a lot of questions as this is not the first incident on the N4 where the culprits' placed rocks on the road, causing damage to the vehicles forcing their victims to pull off the road in order to rob or kill them. "What are the police doing to find my brother's killers. What are they doing to keep motorist on the N4 safe?" he said

Police spokesperson Lieutenant Colonel Mavela Masondo said that the police in Akasia are investigating a case of murder after a man was found dead in a vehicle on the N4 towards Orchards also on 7 May. It is reported that the South African Police Services and Tshwane Metro Police Department members were called to a scene where they found a body of a man with gunshot wound inside an Audi which was missing a front tyre and keys. The circumstances surrounding this incident are unknown at this stage and the victim is also not vet identified. The Kidson family is shattered by Juandré's death but has received overwhelming support from the community. "We would like to thank everyone for their support during this difficult time. We are grateful for every prayer, every meal and every candle that you lit in Juandré's memory just to name a few.

If the answer is yes, then it is advisable to take some time to verify if the tertiary institution is actually registered with the department of Higher **Education and Training** 

Education is valuable and it is every parent or guardian's dream to see their children furthering pre-requisite.

their education after high school.

Unfortunately, many students discover - just after completing their training - that the institution they had been enrolled with is not registered with the Department of Higher Education and Training.

A college or university that is not registered with this department is not permitted to offer any courses and will actually be operating illegally!

This also means that certificates awarded by such institutions are not accredited and that students who enrol for them are taking a huge gamble with their future - whether they know it or not.

Like all schools, institutions of higher learning must operate within the confines of the law and registration with the department and other training bodies associated with the courses they offer is a

Verifying if an institution of higher learning has a certificate that is recognised is important to know before registration.

It is also advisable for students to check the details and website of such institutions. Also check their registration number. Prospective students are also advised to visit the college so that they are able to physically verify if the college does exist.

South Africa has a register of all qualifications which is managed by the South African Qualifications Authority (SAQA) and this register is referred to as the National Qualifications Framework (NQF).



# **NSPCA/Afriforum challenge SAPS** incompetence over SANDF horse abuse case.

NW - Since 2018, the NSPCA has been given bring animal abusers to book. the run-around regarding two of its cases In May 2018, the first case was opened, after abuse of over one hundred horses. It has been four years since the NSPCA opened its prosecutor to consider for court.

The NSPCA has now approached the Commissioner of Police in the North West province to urgently intervene in this matter. A formal complaint has been lodged with

the commissioner, Lieutenant General SJ Kwena, in a formal letter sent by Private Prosecutor, Gerrie Nel, from Afriforum, who is representing the NSPCA in this matter.

In the letter, Advocate Nel draws attention to the NSPCAs frustration regarding the indifferent attitude that this case is being handled with.

The NSPCA, through Afriforum, had formally written to Colonel Selepe and Colonel Bekker on two different occasions compiled and submitted case dockets to in March and April 2022 respectively. The letters highlighted the fact that the NSPCA has been trying to take this matter to court since 2018, and reiterated that the NSPCA was willing to assist the detectives if required. No acknowledgement or response was received from either of the two Colonels on both occasions.

In light of the above, the NSPCAs complaint refers mainly to the inept and unprofessional work ethic of the SAPS Potchefstroom detectives assigned to this case- who have this matter. blatantly refused to work with the NSPCA to NCPCA press release dated 10 May 2022.

against the defence force (SANDF) for the the NSPCA was forced to remove 76 horses from the SANDF's South African Army Special Infantry Capability. An additional 25 first case against the SANDF and the SAPS horses required emergency euthanasia on have still not handed over the case to the the premises of the SANDF because of how severely compromised their state of health

> In 2019, during an inspection, NSPCA inspectors witnessed members of the SANDF brutally kicking and beating other

horses which resulted in the NSPCA removing those horses as well.

> This resulted in a second case being opened by the NSPCA in February 2019.

It appears to the NSPCA as though the accused members in this case (members of the SANDF) are imposing their will on senior detectives in the SAPS which places this case in jeopardy.

NSPCA The had investigated, the SAPS. The dockets contained sufficient evidence against the accused's in this case from the NSPCAs investigation.

The detectives in this matter simply had to collect additional information required by the prosecutor to complete the docket. It appears to the Council that the detectives for this case have failed to do so after FOUR years.





Rustenburg – Platinum Weekly was made aware of a man pretending to be a lodge owner in our area, so we set out to investigate. We ended up going down a rabbit hole of scams. The audacity of this serial scammer is mind boggling. We are placing only one or two of his scams (per week) in our newspapers. We already interviewed several of his victims. This serial scammer is also extremely dangerous and armed. He was recorded online, taking out his gun and threatening to shoot a man who confronted him about his scams

It almost plays out like a movie...

except it's not. It's real life and it's real people who lost real money. It is a pity, however, that only some of his victims have opened criminal cases against him. In some of the cases his scams appear to be nothing more than a power play... a need to impress the ladies...

More and more victims are coming forward and *Platinum Weekly* aims to expose all of his scams in the weeks ahead. We hope to warn people about his *modus operandi*, so that they don't get caught up in his web of lies. Hopefully he will be brought to book soon so that his identity can be revealed.





SA - Most people involved in an accident report the case to the police just for the case number so that they can claim from their insurance or even the Road Accident Fund. Some feel that if they don't have insurance, it's not necessary to report the accident.

Platinum Weekly spoke to police spokesperson Captain Sam Tselanyane about the procedure when involved in an accident: "It is the responsibility and duty of every driver to report an accident in which a person was killed or injured immediately or at least within 24 hours after the occurrence and not to remove any vehicle until such removal is authorised by a police official," he said. Failing to do so would be contravening Section 61(1) (a-e) of the National Road Traffic Act, 1996 (Act No. 93 of 1996)

Police spokesperson captain Elsabé Augoustides added: "Police attend accidents where there are serious injuries or people killed, as well as when a crime has been committed, for instance where reckless and negligent driving or drunken driving is suspected.'

Although emergency services often inform police of the accident if they arrive, and the police are not yet on the scene, it is still the responsibility of the drivers to ensure that the accident is reported.






## Louwrens putts his way to victory



"We have to make sure the players are well grounded in these basics first so we will continue coaching them until they excel and then consider playing them against other football teams," Tlou said.


He said their approach is in line with their vision of producing players capable of competing in the professional ranks in South Africa and even beyond the boarders of the country.
