DUO UP FOR R5 MILLION FRAUD

Rustenburg – A case in which a man and a woman stand accused of defrauding a company of R5 million has been referred to the Specialised Commercial Crimes Court in Rustenburg.

On Tuesday 23 May 2023 Dineo Precious Powane appeared before the Rustenburg Magistrates' Court to face three charges of money laundering. The court appearance is related to a case in which a 44-year-old man was arrested for allegedly stealing over R5 million from his former employers.

The man, Evans Mutale, is facing 21 charges of fraud and three alternative charges of money laundering. He has also appeared before the Rustenburg Magistrate Court.

Mutale, who was arrested on 12 April 2023 in Rustenburg, stands accused of stealing R5 million from his former employers, Jaira Constructions and Projects, and then depositing the money into Powane's account.

National prosecuting authority (NPA) regional spokesperson Henry Mamothame said that Mutale was employed at the company as an accountant responsible for managing accounts, payroll, and loading payments when he committed the crime. "Powane was granted R3,000 bail while Mutale is out on R10,000 bail. Their matter will now

appear at the Specialised Commercial Crimes Court in Rustenburg, for pre-trial conferencing," Mamothame said. Both suspects are expected back in court on 7 June 2023.

"It is alleged that between September 2019 and November 2020, Mutale fraudulently transferred money into an account belonging to Powane, who has no links to the company but is known to him," Mamothame added.

"These transactions were allegedly done under the pretence of paying a service provider for services rendered to the company. In the process, he deceived his supervisor to make final authorisations for the money to be transferred into Powane's bank account," Mamothame explained.





COMMUNITY JOINS FORCES TO **TACKLE WASTE CRISIS**

Municipal vehicles repossessed



2023 local businesses, volunteers, and community stakeholders such as the VF+ and Derby community policing (CPF) took it upon themselves to rid areas in Derby and Koster of their growing waste problem. Since mid-May Kgetlengriver Local Municipality (KLM) has been unable to provide waste removal services after the last of its service delivery vehicles were repossessed on the 12th of May. The asset seizure is the result of a financial and legal issue dating back to

According to information received, KLMunder former management of Joseph Mogale—leased a fleet of vehicles from Betrobrite Pty Ltd in 2018. However, Betrobrite started with the procedure of urgent basis. The judgement has affected repossessing vehicles from KLM because of payment disputes. On 17 April 2023 a court order was issued to KLM to pay R12,466,266,20. On 12 May 2023 the last vehicles were repossessed. These vehicles were used for KLM's plumbing, electrical, and refuse removal services. As service delivery was affected, refuse removal became an issue. On 27 May local businesses offered vehicles, and volunteers, and community stakeholders such as the VF+ and Derby community policing (CPF) took it upon themselves to remove the rubbish in areas of Derby and Koster.

when KLM announced that it would resume problem.

Derby/Koster - On Saturday 27 May its waste removal duties as it had appointed a contractor to do it. However, according to VF+ councillor at KLM. Stella Potgieter, the solution is only temporary.

> KLM responded to Platinum Weekly's questions on Wednesday 31 May: [extracts] "The Municipality had a lease agreement of fleet with Bertrobrite (Pty) Ltd from 2018 until the termination of the contract in 2019. The service provider obtained a judgement against the municipality for a claim of the amount of R12 466 266.20, which the municipality is challenging through the court after all negotiations with the service provider failed.

> The decision was taken to appeal the judgement against the municipality on an service delivery.

> The municipality has been working around the clock to ensure that waste is collected at the affected areas and the collection schedule is restored to full capacity as from Monday, 29 May 2023.

> The municipality is treating this matter with utmost importance and wishes to apologise to its residents for the current situation and also thanks the residents who assisted with refuse removal.'



Health **Department** clarifies North West cholera cases

North West - The National Department Health would like clarify the laboratoryconfirmed cases of announced cholera by the North West Department of Health on Tuesday 30 May 2023.

It was discovered during the discussions North West health officials that cases. two were already reported under Gauteng, because the two patients were screened, tested and diagnosed with cholera while they were in Hammanskraal.

The positive cases and deaths are counted under the province or district in which they were tested, not where the patients reside.



This means, the province of North West has no confirmed cases nor outbreaks of cholera at the current moment.

Both the National and Provincial Health Departments would like to apologise for the communication error occurred.

Members of the public are reminded to continue practicing personal hygiene, and to wash their hands thoroughly with water and soap or sanitiser before preparing and handling food, or after using bathrooms.

All people who experience cholera-like symptoms (stomach cramps, diarrhoea, dehydration, and vomiting) are urged to present themselves to the nearest health facilities without delays to enable health workers effectively manage the infection.

The case finding and contact tracing activities are ongoing, especially in the affected communities.

32 Mumps cases reported in Bojanala

Rustenburg - The North West Department of Health has confirmed an increase in the number of positive mumps cases that have been reported at public medical facilities in the Bojanala Platinum District Municipality.

Department spokesperson Tebogo Lekgethwane told Platinum Weekly on Wednesday 31 May 2023 that the cases had risen to 32 from the initial 13 which were on record on Friday 26 May

At the time of going to print, nine had been reported in Moretele and four in Rustenburg.

"There is no need to panic. The cases in Moretele and Rustenburg were traced through the local clinics and symptoms were treated there. No patients were hospitalised. Parents were advised to isolate their infected children for a period one to two weeks until they recover." Lekgethwane said.

"The Department wishes to state that the public health sector does not immunise for mumps although some private health facilities do provide vaccines for this condition.

"However, where there is a need, members of public should seek medical attention at the nearby clinics where the symptoms can be treated," Lekgethwane added.

"The disease is generally a mild childhood disease, mostly affecting children between 5-9 years of age. The Department can assure members of the public of the fact that people who have had mumps are usually protected for life against the mumps infection. Second occurrences of mumps are rare," he explained.

He advised community members to isolate children who are infected with mumps for a period of between one and two weeks.

"If necessary, public health facilities can treat symptoms as the disease is expected to dissipate within a period of two weeks or less," Lekgethwane concluded.



Winter's burn hazards

Rustenburg - Winter is a season that comes with burns, especially if they are placed directly on the a lot of excitement, as people get to enjoy the cold weather, hot chocolate, and cosy blankets. However, it also comes with a few hazards that you need to be aware of to keep yourself safe and warm. Job Shimankana Tabane Hospital (JST), professional nurse Hope Banda, shared some advice on how to be safe and warm this winter on Monday 29 May 2023.

JST Hospital sees a lot of patients that come in with burn wounds, and a lot of these are caused by heaters, hot water bottles, electric blankets, and open fires. Therefore, it is essential to know how to keep yourself safe with these items. One of the hazards of heaters is that people tend to sit too close and do not realize they are burning before it is too late. This can cause clothes to melt into the skin and burn, and it can also cause a fire if it falls over. Banda advises that you should wear clothes that are not as flammable, and rather use a blow falls over Additionally it is important to make sure that the wiring of your heater is in good condition.

skin. They can also burst or leak if used improperly or poorly manufactured, causing the boiling water to burn your skin. Banda said that you should not overfill or use boiling water in your hot water bottles, but rather use hot tap water. You should also always use a hot water bottle cover or wrap the bottle in a towel or fabric to prevent it from being in direct contact with the skin. It is also important to remove the hot water bottle from the bed before going to bed to avoid rolling onto it and bursting it, and to replace it the moment it has any damage. Instead of using hot water bottles, heating pads or heated bean bags can also be used.

Electric blankets could also become a fire hazard due to faulty wiring, especially if they are older or poorly maintained. According to Banda you should make sure that your electric blanket is laying flat on your bed and turn them off before climbing into bed. You should also regularly check if the wires heater or an oil heater that won't catch fire when it are still in good condition and not leave them on when you are not at home.

Open fires are also very dangerous, as they can Hot water bottles are also a common cause of cause burns and are toxic when made in an area

that is not well-ventilated. Banda advises that you should not make a fire inside your home, and if you must, you should ensure the area is well-ventilated. Additionally, you should not stand too close to a fire, and children should always be supervised

Apart from these hazards, there are other tips to keep yourself safe during winter. For instance, when boiling water, you should make sure that the handle is not standing out so you cannot bump into it and spill the boiling water on yourself. Also, during winter, you tend to make your bath water a little warmer, but you should always open the cold water tap first. This way, the water is not too hot if you or your child accidentally falls into it. You should also avoid asking young kids to make tea or coffee, as boiling water is very dangerous. If you get a burn injury, you should apply cold water immediately and avoid trying any other remedies like banana skin. Cold water is the best, and if the injury is serious, you should immediately go to the nearest clinic to be treated. Lastly, you should avoid picking at blisters, as this might lead to infection.




