DRAMATIC RESCUE

Joint task force frees hostages, arrests kidnappers

Rustenburg – In a remarkable display of coordinated effort, a joint multidisciplinary task force including members from Provincial Organised Crime, District and Marikana Detectives, Visible Policing, the Tactical Response Team (TRT), Hostage Negotiators, Provincial and Rustenburg Crime Intelligence, the Phokeng K9 Unit, the Local Criminal Record Centre (LCRC), several private security firms, Sibanye-Stillwater, Impala, SSG, and Bravalor Risk, as well as volunteers from the Rustenburg Community Police Forum (CPF) worked tirelessly to

rescue two kidnapped victims and apprehend three suspects on Saturday 13 April 2024.

We are entering a troubling new era where ordinary people are increasingly targeted for ransom, often closer to home and more frequently than we might imagine. It's essential that we remain vigilant, protect our loved ones, and pray such horrors never touch our lives.

The ordeal began on the evening of 8 April, when four armed men invaded a home in Marikana West, tragically killing a 47-year-old man and abducting two others – a 40-year-old man and a 61-year-old woman. The suspects demanded a

ransom, sending distressing video clips to the victims' families the following morning. Through relentless negotiation led by the task force, the ransom amount was significantly reduced. An agreement for ransom exchange was set for 13 April at a local petrol station in Rustenburg. The task force strategically positioned themselves and captured two suspects, aged 23 and 32, during the transaction.

During the arrest, one suspect sustained a non-fatal gunshot wound after attempting to disarm a police officer. The ransom money was recovered, and the suspects, both foreign nationals from Lesotho, led the police to a location near Boitekong where the victims were safely recovered, though they were sent for medical evaluation.

Further investigations led the team to a hideout in the bushes near Marikana West where additional stolen items, including a plasma television and a decoder, were discovered. A 31-year-old woman, also from Lesotho, was arrested in connection with the crimes.

The three suspects were scheduled to appear in the Rustenburg Magistrates' Court on Monday 15 April, facing charges of house robbery, murder, kidnapping, extortion, and attempted murder.

Lieutenant general Sello Kwena, the provincial police commissioner, praised the task force for their dedication and success in bringing the suspects to justice and ensuring the safety of the kidnapped victims.

QUICK-THINKING SON FOIL KIDNAPPING IN PHOKENG

Rustenburg – In a remarkable display of bravery and quick thinking, a 20-year-old man from Phokeng played a crucial role in rescuing his kidnapped mother and aiding in the arrest of two suspects involved in a horrifying early morning crime.

This incident, which unfolded on Monday 8 April 2024, started when a 47-year-old widow was forcefully taken from her home in Chaneng, Phokeng, just outside Rustenburg. According to colonel Adèle Myburgh, the widow who had just returned from work, was ambushed in her driveway by five assailants. They grabbed her Toyota Corolla and forced her into their Mercedes Benz before speeding away. Her son, growing concerned after she did not return from work at her usual time, reached out to check on her. Despite her reassurances, which were made under duress, that she was at a hospital helping a neighbour, her son sensed something was wrong.

By activating the installed tracking system in her car, he discovered the vehicle was not at the hospital as claimed, but in Mooinooi. He wasted no time and swiftly reported his mother as missing at the Mooinooi

police station. This triggered a coordinated response from various police units, including Crime Intelligence, Mooinooi and Phokeng Detective Units, the Tactical Response Team (TRT), and the Tshwane Metro Police Department (TMPD).

The abandoned Toyota was soon located in Mooinooi, and further intelligence led authorities to the Mercedes Benz in Soshanguve. There, the police successfully apprehended two of the suspects. The victim was found unharmed later that day at Akasia police station, following threats by her captors to transfer money through a forced bank transaction.

The suspects, identified as William Aphane (31) and David Mashabela (43), appeared before the Bafokeng Magistrates' Court in Tlhabane on 12 April. Facing charges of kidnapping, armed robbery, and the pointing of a firearm, they were remanded in custody pending a bail application set for 19 April.

Lieutenant general Sello Kwena, the provincial police commissioner, expressed his gratitude towards all the operatives and community members involved in the operation.

Following the discovery of the burglary (I was sleeping when they popped in unnoticed), I immediately contacted both the local neighbourhood watch and the police. The neighbourhood watch responded promptly and arrived within minutes, but unfortunately, the perpetrators had already vanished into the night. Despite their swift reaction, the absence of a police response has been profoundly disappointing. As of now, several days later, I am still waiting for any police officer to arrive or even to receive a follow-up call. We appreciate the efforts of our community policing forum, but the absence of official law enforcement response is a significant concern that needs addressing.

Community mourns the tragic loss of
constable Makola




The late Mogoro Clement Makola

Rustenburg – The North West community is in mourning following the devastating loss of 31-year-old constable Mogoro Clement Makola, who was tragically shot and killed on the evening of Monday 15 April 2024. The incident occurred in Lekgalong village near Marikana, just outside Rustenburg. Constable Makola, who was off-duty at the time, had just exited a local shop when he was confronted by three unidentified men. One of the assailants brandished a firearm and demanded money. During the confrontation, as constable Makola attempted to disarm the gunman, he was shot multiple times in the upper body. Despite his efforts, the attackers fled the scene on foot. Brigadier Sabata Mokgwabone reports that in a desperate bid for medical assistance, constable Makola's wife rushed him to the nearby Kanana clinic. Tragically, he was declared dead upon arrival. The North West provincial commissioner, lieutenant general Sello Kwenja, expressed profound sorrow over the incident and extended heartfelt condolences to constable Makola's family and friends. In response to this heinous crime, a manhunt has been initiated to apprehend the suspects. The police urge anyone with information that could aid in the investigation to come forward. CONNECTION WITH

Rustenburg – Akim Moyo (33) and Tshepang Bome (22) appeared before the Rustenburg Magistrates' Court on Monday 15 April 2024, facing charges of possessing suspected stolen goods, unlicensed firearms, and ammunition. Lieutenant colonel Amanda Funani reported that the arrests of Moyo and Bome were made on Friday 12 April 2024, in Rustenburg's Central Business District (CBD). A police patrol unit conducted a stop-and-search operation on a suspicious vehicle, uncovering cell phones and unlicensed firearms inside. The duo was also implicated in a business robbery at a local

butchery that occurred earlier that day. According to police reports, five armed suspects entered the butchery just before closing time, forcing staff to the ground. The robbers took cash from the tills and other items, then fled in two white vehicles — a Toyota Corolla and a Volkswagen Polo — both bearing Gauteng Province registration numbers. Moyo and Bome are slated to reappear in court for a formal bail hearing on Monday 22 April 2024. Lieutenant general Sello Kwenja, the provincial police commissioner, commended the Rustenburg Flying Squad for their alertness and the pivotal role they played in apprehending the suspects.

MAN IN COURT FOR ALLEGEDLY RAPING 9-YEAR-OLD GIRL

Rustenburg – In a disturbing incident that has shocked the local community, a 39-year-old man is set to appear before the Rustenburg Magistrates’ Court on Thursday, charged with the rape of a 9-year-old girl with disabilities. The arrest followed an alleged sexual assault reported to have occurred on Sunday 7 April 2024, in Freedom Park.

According to the Rustenburg Family Violence, Child Protection and Sexual Offences (FCS) Unit, the accused was with a family when they travelled to Freedom Park for a meeting. After the meeting, the young girl’s parents left her in the car with the family friend while they went to a nearby shop.

Colonel Adèle Myburgh reports, upon their return, they reportedly discovered the accused assaulting their child in the vehicle. The father intervened to stop the attack, and the mother’s cries for help attracted the attention of nearby community members who detained the accused until police arrived.

The police swiftly arrested the man, who was later handed over to the authorities in Phokeng. He has been remanded in custody after his first court appearance on 11 April.

Lieutenant general Sello Kwena, the provincial police commissioner, expressed his approval of the swift arrest, emphasising the importance of the legal process in addressing such serious allegations. The community remains in shock, with local leaders and advocacy groups calling for increased awareness and stronger measures to protect vulnerable individuals.

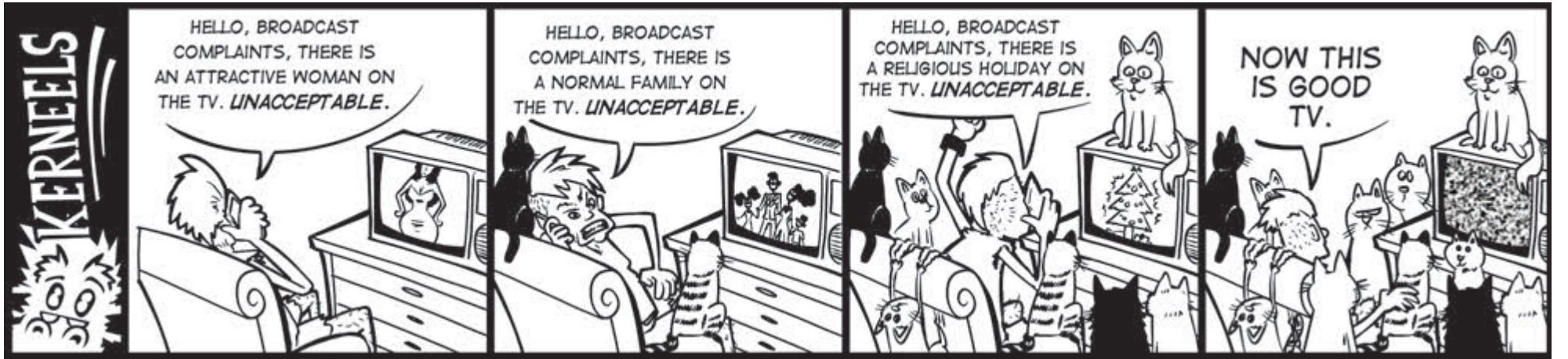
