# R350 Million HAWKS BUST platinum zama zama **SYNDICATE** ecovered RUSTENBURG

Rustenburg – The battle against illegal mining continues to intensify as law enforcement agencies in Rustenburg and Brits successfully dismantled a major illegal platinum syndicate. The low international platinum prices and the complex web of this organised crime have made it a high-stakes fight, with billions of rands at risk.

The scene where the Hawks executed their successful raid, catching the suspects by surprise.

On Wednesday, 7 August 2024, in a coordinated operation, members of the North West Hawks, in collaboration with the KwaZulu-Natal Hawks, the Directorate for Priority Crime Investigation (DPCI) head office's tactical operations management section, the SAPS Airwing, and the Digital Forensic Laboratory, arrested five

Claudette du Plessis (36), George Sambo (37), Michael du Plessis (40), Alphigio Tavavinga (42), and Hendrick Viljoen (67) were apprehended and appeared before the Tlhabane Magistrates' Court the following day, facing serious charges including illegal dealing in unwrought precious metals, theft, and illegal possession of unwrought precious metals.



received about the theft of suspected platinum group material at a mine in Rustenburg, valued at an estimated R350 stored in Rustenburg and Brits, waiting to be sold on the black market. The operation to raids on two premises, catching the perpetrators networks continues. off guard

Initially, seven suspects were taken into custody, but after a preliminary investigation, two were released as they could not be directly linked to the crime. The remaining five suspects have been remanded in custody, with their bail application scheduled for 16 August 2024.

A mining industry insider, who spoke to *Platinum* Weekly on condition of anonymity, highlighted the complexity of illegal mining operations. "Illegal mining is not merely a breach of law, it's a sophisticated operation backed by influential mafia networks, which complicates crackdown efforts," the source explained.

Lieutenant colonel Tinyiko Mathebula, speaking about the operation, remarked, "The alleged stolen platinum, estimated at R350 million, was kept in Rustenburg and Brits for sale. The team simultaneously raided the two premises."

Despite the success of the raid, the anonymous mining expert warned of the broader implications of illegal mining in an already struggling industry. "This underground market thrives because illegal operations usually don't pay any tax, have no legal safety or other regulatory appointments, and have no regard for their environmental impact and accompanied costs," he noted.

The arrests followed critical information Legal platinum producers are currently navigating revenue losses and a weaker demand, making the impact of illegal mining even more pronounced.

# TWO ARRESTED IN RUSTENBURG FOR KANANA TAVERN MASSACRE

Rustenburg – On Sunday evening, 13 August 2024, two male Lesotho nationals, wanted for murder and attempted murder in Kanana near Klerksdorp, were arrested at the Yizo Yizo informal settlement in Tlhabane. The suspects, who are expected to appear before the Bafokeng Magistrates' Court, were found in illegal possession of a firearm and ammunition, among other items

According to sergeant Ofentse Mokgadi, the arrest followed an exchange of crucial information between the station commanders of Tlhabane and Kanana SAPS, sparked by a tip-off. A well-

coordinated tactical operation, led by colonel David Moagi and supported by various police units, successfully apprehended the suspects inside a Wendy house. The police seized a 9mm pistol loaded with live rounds and over fifty loose 9mm live rounds. It is alleged that the two suspects were involved in a violent incident earlier this month at a tavern in Kanana, where eight people were murdered, and eleven others were injured.

The suspects now face charges of illegal possession of a firearm, illegal possession of ammunition, and contravention of the Immigration Act.

# RUSTENBURG **CPF PATROLLER TRAGICALLY KILLED IN THE** LINE OF DUTY

Rustenburg/ Zinniaville - A shocking tragedy has struck the Rustenburg community as the body of 54-year-old Melusi Dladla, a dedicated Community Police Forum (CPF) patroller, was discovered in a bushy area near the R510 road in Tlhabane on Tuesday 6 August 2024. Dladla's lifeless body was found around 04:00 by a passerby, and emergency medical and rescue services personnel confirmed his death at the scene.

Initial investigations, as reported by colonel Adéle Myburgh, indicate that Dladla was shot in the neck while allegedly confronting two suspects. His commitment to protecting his community ultimately led to his untimely and tragic death.

The provincial police commissioner, lieutenant general Sello Kwena, expressed deep sorrow over the loss of a brave community member who was volunteering his time to ensure the safety of others. "The police will work tirelessly to bring these perpetrators to justice," he assured. He also encouraged community members who wish to contribute to the safety of their neighbourhoods to join their local Community Police Forum (CPF) and collaborate with the police through the Community in Blue Patrollers

The police are appealing to anyone with information that could assist in the investigation of Dladla's murder to contact sergeant Whalter Seome at the Tlhabane Detectives Unit on 082 773 0696. Anonymous tip-offs can also be made via Crime Stop at 08600 10111 or through the MySAPS app.

# **PREGNANT WOMAN RAPED, PERPETRATOR** SENTENCED TO 30 YEARS



**Detective constable Patrick Sebalane** successfully tracked down and arrested Matshane eleven days after the crime.

5 August 2024, the Rustenburg Regional Court sentenced Thabiso Matshane to 30 years of direct imprisonment for his aggravating circumstances, and housebreaking, all committed in Boitekong in March 2020.

The acting Bojanala Platinum Sub-District 2 commissioner, brigadier Mamotsamai Ntoagae, along with her management team, expressed satisfaction with the recent sentencing of Matshane.

According to sergeant Ofentse Mokgadi, the court heard harrowing details of the night in question. Matshane, then 26 years old, forced his way into the home of a 27-year-old woman who was seven months pregnant. Armed with a knife, he threatened and raped her, before stealing her plasma TV and cellphone.

The case took a turn when detective constable Patrick Sebalane successfully traced and arrested Matshane eleven days after the incident.

According to colonel Adéle Myburgh, the man allegedly took out a firearm and shot at his ex-girlfriend, fortunately missing her. She managed to escape into the street, where she encountered a police officer. Meanwhile, her brother intervened, overpowering and disarming the ex-boyfriend. The situation

seemed to calm down, and the brother handed the firearm back to the man, who then left the scene. The suspect later went to a nearby bottle store, where he once again discharged his firearm, pointing it at innocent bystanders. Community members quickly intervened, disarming and assaulting the man before police arrived and took him into custody.

The suspect appeared before the Rustenburg Magistrates' Court on Monday 12 August 2024, facing charges of attempted murder and discharging a firearm in a municipal area.






