



**Pilanesberg** – On Saturday 14 September 2024, a male tourist from Portugal was seriously injured in an elephant attack at Pilanesberg Nature Reserve. The incident occurred around 13:00, near Mankwe Dam, in the heart of the reserve. According to eyewitnesses, two individuals were outside their vehicle during a self-guided game drive, seemingly unaware that they were in the midst of an elephant family herd.

An adult elephant, likely a female, issued a warning, which tragically led to the attack. The injured man was rushed to a local hospital for stabilisation before being transferred to a Pretoria hospital for further treatment. Reports from North West Parks and Tourism Board chief

conservation officer, Pieter Nell, confirmed that the man underwent two surgeries and remains in recovery.

"The elephants remained calm after the attack, and there was no further aggression," said Nell, adding that the park's elephant herds are generally known for their calm behaviour around tourists. However, this incident follows a similarly tragic event in July 2024, when a Spanish tourist was fatally charged by elephants under similar circumstances.

These unfortunate encounters serve as a stark reminder that despite all warnings, some visitors underestimate the dangers of exiting their vehicles in close proximity to wild animals. "It's vital for tourists

to remember that these animals are unpredictable and can react violently if they feel threatened," added Nell. Pilanesberg's officials, rangers, and guides consistently educate visitors on the importance of staying in vehicles, keeping a safe distance from animals, and respecting their space.

**The North West Parks and Tourism Board urges visitors to adhere to park regulations to ensure their safety and the well-being of the wildlife. Continuing to ignore these rules not only endangers lives but could also impact the placid nature of the park's elephant population.**

# MAN SENTENCED FOR MURDER AND RAPE


**Rustenburg** – The Bafokeng Regional Court in Tlhabane sentenced 42-year-old Buti Solomon Phege to 12 years for murder and an additional 8 years for rape, following a brutal attack that occurred seven years ago in Lethabong village.

Brigadier Sabata Mokgwabone said the sentences, delivered on Friday 13 September 2024, will not run concurrently, ensuring Phege serves both terms consecutively. Additionally, the court ruled that he is unfit to possess a firearm.

The horrific events unfolded on Sunday, 16 July 2017, when Kgopoleng Motshabi and a woman left an entertainment venue in Lethabong to return home. Earlier that evening, Phege had attempted to propose to Motshabi's companion, an advance she rejected. Undeterred, Phege followed the pair to the woman's residence. There, he brutally attacked Motshabi, stabbing him multiple times and leaving him fatally wounded. He then forced the woman to accompany him to his home, where he threatened her with a knife and raped her.

Motshabi was declared dead at the scene, and after the crimes, Phege handed himself over to the police, where he has remained in custody throughout the legal proceedings. The court's ruling stipulated that Phege will not be eligible for parole without the consent of Motshabi's siblings and the rape survivor.

The provincial police commissioner, lieutenant general Sello Kwenia, and the director of Public Prosecutions, Dr Rachel Makhari, praised the dedicated efforts of investigating officer detective constable Molefe Kgabo, public prosecutor advocate Zola Mpayipheli, and all others involved in the case.

**Rustenburg** – A wildfire tore through thousands of hectares in the Buffelspoort and Modderfontein areas just outside Rustenburg from Saturday 14 September, to Monday 16 September 2024. The fire, which swept over the Magaliesberg mountains, wreaked havoc on homes, properties, and grazing land, leaving behind a trail of destruction and heartache. The fire consumed eight homes, with three completely reduced to ashes, according to Marchant Jacobs, director of JustMED24. Tragically, many animals also perished, and grazing crops and bales were consumed by the flames, adding to the devastation. Oridile Madiba, Rustenburg Local Municipality's acting communications manager, estimated the damage at a staggering R22 million. Despite the scale of the disaster, the fire was finally contained after days of hard work, with the last flames extinguished on Monday, 16 September. Communities, farmers, and local firefighting teams worked together, using heavy machinery, blowers, and beaters to battle the inferno.



One young man sustained second-degree burns during the fire, adding to the human toll. His bravery in the face of the disaster has been acknowledged, and the community wishes him a speedy recovery.

**A Team Effort in the Face of Despair**

The efforts of the local community were nothing short of heroic. "Thank you to everyone who helped," said Charl Visser, owner of Buffelspoort Sekuriteit and member of Kroondal Plaaswag. "We felt hopeless at times, but the unity of everyone kept us going. We are so grateful to those who brought cold drinks, water, and made hydration points available." The North West Umbrella Fire Protection Association has since called for a state of disaster to be declared in the North West Province, following several large fires, including this one in Rustenburg. "All fire brigade services are under-resourced. There is a lack of manpower, qualified firefighters, and equipment," they said, stressing the crucial role that local communities play in fire management. Many residents have purchased firefighting equipment, knowing they often have to rely on themselves and their neighbors to combat these blazes. Unfortunately, the fire risk remains high, with a 75% probability of extreme fire events expected in the coming 7 to 10 days. However, some relief came in the form of 3mm of rain that fell in the Buffelspoort area on the evening of 17 September.

**Community Coordination Saves the Day**

The local community's response was extraordinary. With many residents coordinating via WhatsApp groups and two-way radios, they were able to direct efforts where they were needed most. Their readiness and cooperation provided a glimmer of hope amidst the devastation. "The cooperation and readiness of our local community in Buffelspoort is



a source of comfort. Everyone was in this together," said resident Estie Rupp. Stakeholders involved in the firefighting effort included ambulance services, the Greater Rustenburg Fire Protection Association (GRFPA), and the Rustenburg Emergency and Disaster Management Centre. Eleven emergency personnel from Rustenburg, along with fire engines and additional resources from Bojanala Platinum District Municipality, were deployed to assist. Petra Rough, Chairperson of the GRFPA, expressed her heartfelt gratitude to all those who assisted. "We have been put to the test to the extreme," she said. "From fighting the fire, guiding others, and keeping everyone safe, the community's response was truly remarkable." Rough also extended her thoughts and prayers to the families who lost their homes, and to the young man recovering in hospital.

**The Fire's Devastating Impact**

The fire began on the mountain above Bergheim on Saturday night, fueled by strong winds that pushed the flames both east and west. The rough terrain made access difficult, and initial efforts to contain the fire had to wait until daylight. By Sunday, the fire had reached the R24 and threatened several farms in the valley. Rough estimates that over 500 people from the community came to help, with support arriving from as far as Koster. Firefighters from local services, as well as Mogwase, Marikana, Brits, and

several nearby mines, joined the battle, along with JustMED ambulances, which provided medical assistance. Although the fire burned down homes and left the land scorched, with nothing but ash remaining, community efforts ensured that the fire did not reach other critical areas, including the church near the blaze, which was spared at the last moment.

**Call for Assistance and Donations**

As the community begins to assess the damage, efforts are underway to provide relief to those affected. Donations of animal feed, food, clothing, and more are being collected. Anyone in need of assistance can contact Estie Rupp via WhatsApp at 083 578 9210 or Annetjie Oberholzer at 082 463 2698 for human needs. Among the victims of the fire are Thomas and Heidrun Wenhold, whose house in Modderfontein was completely destroyed on Sunday night. "We lost many of our family photos and heirlooms," said Thomas. Fortunately, they had house insurance, but the loss of personal memories weighs heavily on them. Those wishing to assist the Wenhold family or other affected residents can coordinate with Estie Rupp.

**A Community Stands Strong**

As the ashes settle, the spirit of the Buffelspoort and Modderfontein communities remains unbroken. Through teamwork, resilience, and an unwavering commitment to one another, they have shown that even in the face of disaster, unity prevails.

# BODY FOUND IN GEELHOUTPARK: SAPS OPEN MURDER INVESTIGATION

**Rustenburg** – In the early hours of Monday, 16 September 2024, a grim discovery was made in Hard Pear Avenue, Geelhoutpark Extension 4. At approximately 06:00, a body was found lying on the roadside.

Gerhard Janse van Rensburg, deputy chairman of the Community Police Forum (CPF) Sector 2, received the call that led to the discovery. “One of our members contacted me about the body. It was near my home, and I immediately went to the scene. SAPS arrived shortly after,” Janse van Rensburg reported. The Rustenburg South African Police Service (SAPS) has since opened a murder investigation. SAPS communications officer, Ofentse Mokgadi, confirmed the news, stating that although a murder docket has been filed, the circumstances surrounding the incident remain unclear. Authorities are working to piece together the events that led to the death, with an active investigation now underway.



# SAPS WARNS OF RISING FRAUD IN NORTH WEST

**North West** – The South African Police Service (SAPS) in the province has expressed growing concern over the increase in fraud cases across Rustenburg, Hartbeespoort Dam, Lichtenburg, and Klerksdorp.

Brigadier Sabata Mokgwabone said that despite ongoing warnings from both the police and financial institutions, fraudsters continue to target unsuspecting individuals. In one of the incidents reported in Hartbeespoort Dam, a fraudster impersonating a bank employee contacted account holders, claiming to be from the bank’s fraud department. Victims were asked to urgently log into their banking app to prevent fraudulent transactions. However, this led to the fraudster gaining access to the victims’ account details, which allowed them to withdraw funds.

Another case in Hartbeespoort Dam involved a message sent to a victim claiming that they were the beneficiary of a relative’s estate from abroad. The victim was instructed to pay taxes and clearance fees to receive the inheritance. After making the payments, the victim never heard from the fraudster again. In addition to these scams, potential car buyers across the region have been lured by fraudulent advertisements on platforms like WhatsApp and Facebook. Scammers would entice buyers with vehicles offered at incredibly low prices,

claiming the cars were about to be auctioned. The fraudsters would request deposits to secure the vehicles, often sharing fake documents to legitimise the deal. After payments were made, the cars were never delivered.

**To protect members of the community from such scams, SAPS has issued the following safety tips:**

- If you receive suspicious calls, hang up immediately if you feel pressured and contact your bank’s fraud department.
- Bank employees will never ask for a One-Time Pin (OTP). Never share your OTP with anyone.
- Never provide personal information like your ID, password, or PIN to anyone over the phone.
- If you don’t know of a relative who lives abroad, chances are there is no inheritance. Don’t pay any fees for taxes or clearance.
- Always view a vehicle in person before making any payment. Legitimate auctioneers will allow you to view the vehicle during business hours.
- Avoid responding to suspicious emails, SMS messages, or letters.
- Set sensible transaction limits on your bank accounts.
- Be cautious of deals that seem too good to be true — most of the time, they are too good to be true.

# MARMOSET MONKEYS



**SA** – Specialised Security Services alerts the public to a recent scam targeting individuals interested in purchasing marmoset monkeys. This is one of many recent examples of the public being interested in buying exotic pets and not necessarily expecting the hurdles and pitfalls associated with this type of purchase.

**MODUS OPERANDI**

- **Scam offer**  
These scammers advertise marmoset monkeys for sale, typically priced at R3,000 each or R5,000 including transportation costs.
- **Client interaction**  
Our client agreed to pay R5,000 for the monkeys, including transport from Springbok to Vanderbijlpark. They paid a deposit of R2,500.
- **Fake verification**  
The scammers provided a copy of an ID for verification, which appeared legitimate as it matched the details on Truecaller.

• **Unexpected additional costs**  
After booking the delivery, the client received an email demanding an additional R15,000 for insurance, supposedly refundable upon delivery. This cost had not been disclosed initially.

• **Suspicious details**  
The email requesting additional funds lacked professionalism, had no official invoice, no company number and included bank details only in the body of the email. The scammers used the name of a legitimate company, Trans Global.

• **Company verification**  
Upon contacting Trans Global, our client discovered that the company does not deal with animal transportation. Trans Global was aware of the scammers misusing their name on various occasions in fraudulent transactions.

# The Myth of the Rife Machine and the Dangers of Pseudoscience

[letter to the editor]



**Dear Editor,**

It is baffling to see how some people still believe in the supposed healing powers of the Rife machine, a device from the 1930s invented by Royal Raymond Rife that claims to cure ailments like cancer through electromagnetic frequencies. The allure of a simple solution is understandable, but we must address the glaring flaws and dangers of this pseudoscientific device.

The Rife machine supposedly targets diseases by zapping pathogens with specific electromagnetic frequencies. Proponents claim that by tuning the machine to the right frequency, it can destroy bacteria, viruses, and even cancer cells. Its supposed mechanism of action does not align with established biological principles.

If certain frequencies truly held the key to health, then by the same logic, other frequencies could harm us — should we be cautious if someone laughs at a particular pitch or if our favourite song plays in an ‘unlucky’ frequency? Such ideas are clearly absurd and highlight the flawed thinking behind the Rife machine’s claims.

The average range of the Rife machine is 1 to 1,000 Hz, frequencies that are common in everyday life. Our electrical appliances, the Earth’s magnetic field, and even our bodies naturally operate within this range. For instance, household power lines run at 50 or 60 Hz, and our hearts beat at roughly 1 Hz. Listening to music or to someone laughing can also cover the whole range as emitted by the rife machine. These frequencies are part of normal, safe interactions with our environment. To suggest that these everyday occurrences could be used to treat serious diseases is misleading at best and dangerous at worst.

Health authorities worldwide, including the U.S. FDA, Health Canada, and regulatory bodies across the UK, Australia, and the EU, have consistently warned against the use of the Rife machine. These organisations classify it as unapproved, untested, and illegal to market for medical purposes. They have also noted the potential health risks when individuals opt for such unproven treatments over established, evidence-based medical care. Skipping conventional treatments in favour of devices like the Rife machine can lead to the worsening of conditions, progression of diseases, and in severe cases, death.

Believing in the Rife machine is not only a waste of money but a dangerous diversion from proven medical treatments. Instead of relying on gadgets that promise miraculous cures without scientific backing, we should trust in methods tested and approved by the scientific community. Always consult with qualified healthcare professionals for evidence-based treatments that have been shown to work.

Let’s keep our health grounded in reality, not in the frequencies of wishful thinking.

**Rustenburg** – Zimbabwe is a paradise for bird lovers, offering some of the most rewarding experiences for both novice and seasoned birders alike. With over 670 bird species, the country boasts a stunning array of habitats, each home to unique bird species. During July 2024, members of BirdLife Rustenburg embarked on an unforgettable birding adventure to Zimbabwe, visiting diverse landscapes ranging from the vast Gonarezhou National Park to the scenic Eastern Highlands. Gonarezhou, located in the southeast lowveld, is a remote, unspoilt haven for birders, known for sharing many species with the northern areas of the Kruger National Park. Meanwhile, the Eastern Highlands, with its mountainous terrain, forests, and montane grasslands, offered the group a completely different experience, featuring restricted-range species such as Swynnerton’s Robins, Chirinda Apalis, and Roberts’s Warbler.

The Mashonaland plateau, with its vast miombo woodlands, also did not disappoint. It is home to the famous ‘miombo specials,’ a group of birds every birder dreams of spotting, including the elusive Spotted Creeper.

At the monthly BirdLife Rustenburg meeting (on Monday 16 September 2024), Hanti Mathews, Pieter Strydom, and Gerda Welman took members and guests on a visual journey through Zimbabwe’s birding hotspots. Their photographic presentation showcased Zimbabwe’s breathtaking landscapes and also featured stunning images of some of the country’s endemic and near-endemic bird species, such as the Grey Waxbill, Red-necked Falcon, Red-throated Twinspot, and Variable Sunbird.

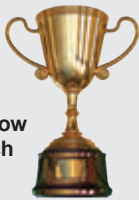
