Rustenburg - On Sunday 13 October any criminal activity to the police and let 2024, at approximately 07:30, a case of mob justice unfolded at the Zinniaville

According to witnesses, two individuals allegedly mugged a teenager from the area around 04:00 that morning. In response, community members retaliated by attacking the suspects with sharp objects and unknown weapons. One suspect was declared dead at the scene, while the other was transported to a local hospital with severe injuries.

Ward 43 councillor Luan Snyders urged the community to refrain from taking justice into their own hands: "Mob justice only leads to more tragedy. Please report

the law take its course. Taking matters into your own hands can have devastating consequences for everyone involved."

South African Police Service (SAPS) communications officer Ofentse Mokgadi said: "We can confirm that one person was found by a passerby on Sunday mornin and another was taken to hospital. It is alleged that these two individuals are foreign nationals. One was declared dead at the scene, and the other remains hospitalised with serious injuries. The police are investigating."



# Two Seriously Injured in N4 Crash, One Airlifted for Urgent Care





Rustenburg – On Sunday 13 October 2024, a collision occurred on the N4 near the Dr Moroka offramp, involving two vehicles: a white BMW carrying five passengers and a Toyota bakkie with two occupants.

According to the manager of Bojanala Ambulance Services, Rufus Nong, the situation was critical for the two individuals in the Toyota bakkie. Eyewitnesses reported that the driver was driving erratically, hitting a car and a pole before eventually crashing into the restaurant.

Fortunately, no one was injured. Marchant Jacobs, operational director at JustMed24, confirmed, "The driver did not sustain any injuries."

The green Nissan Navara bakkie came to a stop inside the restaurant after the driver lost control.

#### TRAGEDY ON THE N4: FOUR LIVES LOST IN FATAL COLLISION



The severely damaged Toyota Corolla, where two passengers perished, leaving only the driver as the sole survivor of the fatal crash.

Rustenburg – A devastating accident on Wednesday, 9 October 2024, at approximately 16:00 on the N4 near Moedwil, claimed the lives of four individuals in a head-on collision between a Volkswagen and a Toyota Corolla.

According to reports, two people were in the Volkswagen (the driver and a passenger), while the Toyota Corolla carried three occupants (a driver and two passengers).

Marchant Jacobs, operational director of JustMed24, confirmed the heartbreaking news, stating, "Both of the people in the Volkswagen and two of the passengers in the Toyota Corolla lost their lives. The only survivor of the accident is the driver of the Toyota Corolla."

Rufus Nong, manager of Bojanala Ambulance Services, also expressed his deepest condolences to the families and community affected by the tragedy, recognising the immense loss.

# **CHOLERA WARNING FOR VAAL AND HARTS RIVERS IN NORTH WEST** AND NORTHERN CAPE

The Department of Water and Sanitation (DWS) has issued a warning on Wednesday 9 October 2024 to communities along the Vaal and Harts rivers, from Christiana downstream, following the detection of cholera bacteria in raw water during routine sampling at five sites, including Wentzel Dam, Schweizer Reneke, and Barkley West.

Residents are urged not to drink or come into contact with untreated water from these rivers. Follow-up testing is ongoing to assess the full extent of the contamination.

The Vaal River, which supplies water to several provinces, including Gauteng and North West, is essential for domestic, industrial, and agricultural use. However, it carries risks of contamination, and the DWS advises the public to avoid using raw water unless it is properly disinfected. As a precaution, residents are advised to boil water intended for drinking.

At the time of going to print, no feedback had been received. Some residents reported that their electricity was restored on Wednesday, 16 October 2024, although the supply remained inconsistent, with several outages occurring the day before.

The alleged offences date back to her time practising as an attorney between 2009 and 2011. In June 2021, Diale was officially charged with six counts of theft, and the Legal Practice Council subsequently removed her from the roll, barring her from continuing her legal practice.




