ELDERLY MAN TARGETED IN DAYLIGHT ROBBERY AT DONKERHOEK CEMETERY

Rustenburg - A Sunday morning visit to Donkerhoek Cemetery turned into a frightening ordeal for elderly Rustenburg resident, who was robbed at knifepoint on 27 October 2024.

Around 10:00, he arrived at the cemetery to tend to his parents' grave, a weekly tradition of respect and remembrance. But as he approached the grave, he was confronted by an unfamiliar man who initially claimed he was looking for work.

"Out of nowhere, he approached me, asking if I had any work for him," he recounted in an interview with Platinum Weekly. "When I made it clear I wasn't interested, his attitude changed. He grew aggressive, pulled out a knife, and demanded my phone. After taking it, he fled."

South African Police Services (SAPS) colonel Adel Myburgh confirmed the robbery and noted that the elderly man has filed a formal complaint. "The elderly man was threatened with a knife and robbed of his phone," Myburgh stated. "We are currently investigating the case."

Members of the Rustenburg Crime Community Forum (RCCF) arrived at the cemetery shortly after the robbery but were unable to locate the suspect, who had quickly disappeared from the scene. RCCF described the suspect as tall and slender, dressed in a black hat, white shirt, and black trousers

RUSTENBURG SCHOOL ADMINISTRATOR FACES 175 COUNTS IN R1 MILLION FRAUD CASE


Rustenburg – The Rustenburg Magistrates' Court has postponed the high-profile case against Ofentse Solomon Molemane (34) to 14 November 2024. Molemane, who faces a staggering 175 counts of fraud and theft, made his first court appearance on Monday 28 October 2024, following his voluntary surrender to the police. He was granted bail of R5,000 under conditions requiring him to report to the Mogwase police station twice weekly and to surrender his passport to authorities. Molemane, formerly employed as an administrative assistant within the Department of Education in Rustenburg, held a trusted position that included financial duties for a local school.

Serving as a financial officer on the school governing body (SGB) and an authorised signatory on the school's bank account, he was entrusted with handling transactions solely for school-related expenses. However, investigations have

revealed a darker side to his role, implicating him in large-scale theft involving over R1 million. According to court disclosures, Molemane is suspected of using his position to transfer school funds into his personal account multiple times between January 2019 and March 2020. In addition, records indicate that in March 2020, Molemane allegedly transferred six separate payments from the school's account to his girlfriend's account. This second suspect, who remains at large, is believed to have had no legitimate ties to the school and rendered no services warranting payment, deepening the severity of the charges.

Dr Rachel Makhari, the director of Public Prosecutions in North West Province, praised law enforcement and the prosecution team for bringing the case to court and reaffirmed the National Prosecuting Authority's commitment to holding public officials

UNLAWFUL **FIREARMS AND EXPLOSIVES** BUST



Rustenburg – In the early hours of Tuesday, 22 October 2024, a collaborative effort between the Vala Umgodi team, the Local Criminal Record Centre (LCRC), and the Explosives Unit led to the arrest of a man in Robega village, near Phokeng outside Rustenburg, for illegal possession of firearms and explosives.

The arrest was made after authorities received intelligence about illegal activities involving dangerous weapons in the area. During the operation, police seized a 9mm Taurus pistol loaded with nine rounds of ammunition.

The suspect, identified as 45-year-old Godfrey Nkunyanebomvu, allegedly admitted to not holding a valid firearm license. A thorough search of his residence uncovered a range of ammunition and explosives hidden in his bedroom.

As officers were leaving the property, they conducted a search of the suspect's Toyota Fortuner, leading to the discovery of

a Norinco pistol with a filed-off serial number, along with a magazine and five rounds of ammunition. Preliminary investigations revealed that the Taurus pistol belonged to a Zinniaville resident and had been reported stolen during a robbery in Marikana in May 2022.

Brigadier Sabata Mokgwabone confirmed that Nkunyanebomvu appeared before the Bafokeng Magistrates' Court in Tlhabane on Wednesday, 23 October 2024, facing charges of unlawful possession of firearms, ammunition, and commercial


North West provincial commissioner, lieutenant general Sello Kwena, welcomed the successful operation, commending the team's efforts to curb illegal firearm possession. "These items are often used to commit crimes, including during illegal mining operations." Kwena stated, underlining the importance of cracking down on such offenses for community safety.

RUSTENBURG SHOPS IN ASHES AFTER TAXI RANK FIRE



Rustenburg - On Friday evening, 25 October 2024, a fire engulfed three local businesses at the Rustenburg Taxi Rank, reducing popular spots like the Pirates Casino Club, Super Fry supermarket, and a traditional medicine shop to ashes. The fire, which erupted at around 20:00, remains a mystery as to its exact starting point, with witnesses divided over whether it began on the roof or within one of the affected stores.

"Some people noticed smoke rising from the roof and rushed inside to warn those inside," explained a street vendor stationed nearby. He speculated that faulty wiring might have ignited the flames, which quickly spread, leaving businesses scrambling to save whatever they could.

Rustenburg Local Municipality spokesperson Odirile Madiba

confirmed that the Emergency and Disaster Management team responded swiftly, preventing further spread. "Our teams contained the fire, and thankfully, no one was injured," said Madiba. The extensive effort involved multiple firefighting units from Rustenburg, Anglo American Platinum, Bafokeng EMRS, and Kgetleng, with over 20 firefighters working to battle the blaze until it was fully extinguished around 23:30

SAPS provided support at the scene, and the cause of the fire is currently under forensic investigation, said police spokesperson colonel Adele Myburgh.

Rustenburg - The SAPS Vala Umgodi team made a significant arrest on Monday afternoon after following up on a tip-off, which led them to the Bethlehem Drive Taxi Rank in Rustenburg. A 50-yearold male suspect was apprehended, found with a black refuse bag containing a hefty 4.5 kg of dagga. The man was charged with possession of dagga and faced his first appearance before the Rustenburg Magistrates' Court on Monday 28 October 2024.

In other police actions, a 36-year-old man in Mooinooi was fined R500 for selling illicit cigarettes, contravening the Counterfeit Goods Act (Act No. 31 of 1997).

Police in Marikana also intervened on Thursday evening, 17 October 2024, when they caught a 26-year-old female suspect violating the Liquor Act (Act No. 27 of 1989) by selling alcohol without a license. Officers seized a range of alcoholic beverages from her premises, issuing her a R300 fine.

Petra Rough, chairperson of the Greater Rustenburg Fire Protection Association, described the situation as intensely challenging. "It started in green pasture, but the heat was intense, and the winds only made things worse. The fire was so fierce it even jumped across the R24," she recounted

Fortunately, a collaborative response from the Greater Rustenburg Fire Protection Association, the local Fire Department, and area farmers helped contain the blaze. DA Ward 36 representative. Jean Keyser, acknowledged the efforts, noting, "The Fire Department, Greater Rustenburg Fire Protection Association, and some of the farmers of the area were also involved in fighting the fire. 




