but that's all it takes," Delta said. "To other drivers, I say: do not stop. Keep moving and pull over safely

Delta said the individuals involved appeared to be adult males. He was driving alone at the time and did not observe any parked vehicles or other pedestrians nearby, aside from the men on the road. This stretch of the N4 is a lifeline for thousands of commuters — but one wrong moment could turn deadly. Delta hopes his close call serves as a wakeup call to others: stay alert, and never stop in an unsafe area.

### "Statutory rape is a crime – NOT a custom"

**SA** – The Public Servants Association (PSA) is calling on government to urgently investigate and prosecute all cases of statutory rape in a bid to address the rising crisis of teenage pregnancy in

This call follows alarming statistics showing that over 122,000 teenagers gave birth in the past financial year. Shockingly, this includes 2,716 girls aged 10 to 14 and 119,587 girls aged 15 to 19 - children still in their own formative years now faced with raising children themselves. On 1 January 2025 alone, 80 teenagers gave birth across the country. Although this number reflects a drop from the 190 recorded in 2024, the PSA insists that even one child giving birth due to statutory rape is too many.

"These girls are often forced to drop out of school, condemning them to a future of limited opportunities. But what is worse - there is no clear correlation between these births and criminal cases. That means perpetrators walk free," said the PSA.

Statutory rape laws exist to protect minors who are legally too young to give consent. Yet, the PSA points out that the absence of prosecutions suggests a failure in enforcing these protections. The association is urging a collaborative response from the Departments of Education, Health, Home Affairs, Social Development, Justice, and the South African Police Service. While laws and policies are in place, implementation and accountability remain lacking.

The PSA also condemned the tradition of resolving such matters quietly through family negotiations, stressing that this practice is not only outdated but illegal. "No matter the perpetrator's social standing, statutory rape must be treated as a crime - not a custom to be settled behind closed doors.

With this urgent call to action, the PSA hopes to shift the focus from reactive care to proactive justice. "To reduce teenage pregnancies, we must begin by protecting children from abuse and prosecuting those who rob them of their childhood."



### **ERM CVS to Conduct a Follow Up IRMA Assessment of Sibanve-Stillwater Rustenburg Operations**

ERM CVS Seeks Input from Local Community and Other Stakeholders

Today, 4 July 2025, ERM CVS announces that on 4-8 August 2025, auditors will visit the Sibanye-Stillwater Rustenburg operations, located in the Rustenburg Local Municipality, South Africa. This is an extension of the independent, third-party audit initiated in November 2024 against the Initiative for Responsible Mining Assurance (IRMA) standard.

During this August 2025 audit extension, ERM CVS will be collecting feedback from local stakeholders – anyone directly or indirectly affected by the mine -- including community members, mine workers, and government officials. Feedback can be provided on all of Sibanye-Stillwater Rustenburg operations, including the Kroondal operations, which will be a special focus. The ERM CVS team will also inspect the operation and its associated facilities.

When the audit is finished, an IRMA assessment results in a public audit report released locally and on the internet. This report will describe how ERM CVS scored Sibanye-Stillwater Rustenburg Operations against each of the 400+ requirements of the IRMA Standard for Responsible Mining, and why ERM CVS gave Sibanye-Stillwater Rustenburg Operations that score. The report will also assign an overall achievement level: IRMA Transparency, IRMA 50, IRMA 75, or IRMA 100.

Sibanye-Stillwater can use this information about the environmental and social impacts of the Rustenburg operations, inclusive of Kroondal, to improve its practices. Other stakeholders, particularly affected communities, may use this audit report to engage with Sibanye-Stillwater and others on a more equal footing to improve the operation in the ways that matter most to them.

I recently came across an article on MyBroadband titled "Signs diesel car drivers in South Africa should look out for regarding contaminated diesel" (28 June 2025, by Hanno Labuschagne), which raised a red flag that hits close to home for us

The piece highlights a troubling trend: diesel being illegally mixed with cheaper paraffin — sometimes up to 68% — before reaching unsuspecting motorists. The South African Revenue Service and law enforcement recently cracked down on two million litres of this adulterated fuel. But what about the damage already

If any of these show up after a refuel, it might not be your vehicle — it could be the diesel itself. Fuel suppliers must be held accountable, and we as motorists must remain alert. I urge your readers to report suspicious fuel stations and to share their stories, so we can protect each other from becoming the next victims of this costly fraud.


