

Suspects fled with cash

The remaining suspects fled on foot with the cash bag after abandoning their blue SUV. A major police manhunt is now underway.

Medical Scheme

The mining industry exposes mine workers to a myriad of on-site dangers and occupational diseases. fleeing were the dogs — barking furiously from inside the house. In the video, one suspect can even be heard muttering "Eish!" as they retreat into the darkness. The family immediately phoned their son, the police, and

security. "Our son arrived very quickly," the victim says. Thankfully, no injuries were reported.

HUSBAND MISSING AS SEARCH INTENSIFIES AFTER BRUTAL MURDER

Rustenburg/ Phokeng – The Phokeng community has been left shaken by new developments in the murder investigation of a 27-year-old woman found dead in her home in Punodung (Phokeng) on Sunday evening, 16 November 2025.

Police spokesperson sergeant Ofentse Mokgadi confirmed that late on Tuesday night, 18 November 2025, police recovered the missing husband's white Nissan NP300 bakkie in Luka, near Leragana Dam. Despite this breakthrough, there is still no sign of the husband, and his whereabouts remain unknown. Specialised police units and multiple stakeholders spent the day combing the area around the dam, making use of advanced search equipment as the hunt intensifies.

The tragic case began when police responded to a complaint

and were met with a horrific scene. Inside the victim's main bedroom, officers found the young woman lying on her back with severe head injuries, including open wounds. The house was in disarray, and investigators recovered a broken bottle with bloodstains as well as a container containing an unknown substance. An autopsy will determine the exact cause of death, while the murder weapon has yet to be identified.

Police are urgently appealing to anyone who may know the husband's whereabouts - or who may have information that could assist the investigation – to come forward. Members of the public can contact detective sergeant Sindisa Seshabela on 076 834 4164 or reach out to their nearest police station.

The National Prosecuting Authority (NPA), through its North West spokesperson Sivenathi Gunya, confirmed that the third accused — Zimele Mntuyazi Nkwanyana (37) — will return to the Rustenburg Magistrate's Court on 2 December 2025 for closing arguments in his bail application.

Nkwanyana was arrested in Port Shepstone, KwaZulu-Natal, and first appeared on 10 October 2025, with a follow-up appearance on 17 October for the formal bail application. His case forms part of the wider investigation into Gumbi's murder in August 2023.

Rustenburg - The pursuit of justice in the murder of well- This development follows the sentencing of the two main perpetrators, Sibongiseni Ngubane (33) and Thabani Lethukuthula Gwala (30), who were handed life imprisonment for murder and an additional 15 years for possession of an unlicensed firearm — sentences that will run concurrently. Gumbi was tragically gunned down outside a Rustenburg coffee shop after stepping out to take a phone call while his wife remained inside their vehicle. Swift investigation, surveillance footage and fingerprint evidence helped link the

30,000 litres stolen in late-night fuel theft

Rustenburg - A major fuel-theft incident took place on Wednesday evening, 5 November 2025, when criminals siphoned an estimated 30,000 litres of petrol from the Tarlton-Rustenburg pipeline.

According to Charl Visser, owner of Buffel Sekuriteit and member of Kroondal Plaaswag, a pressure drop was detected at approximately 23:00. The illegal tap-off point was found just before the Sugarbush Hill turn-off (Rietfontein, Rustenburg), where suspects had cut into the underground pipeline.

A case has been opened with Marikana SAPS by Bidvest, the company responsible for safeguarding that section of the line. Visser confirmed that no photographs were taken due to the active nature of the investigation. The Hawks later confirmed that the Rustenburg Directorate for Priority Crime Investigation is handling the matter.

24-Hour Repair Completed After Illegal Tap-Off

In response to an enquiry from Platinum Weekly. Transnet Pipelines confirmed the fuel theft, stating that the crime occurred in Rietfontein, near Buffelspoort.

Transnet's security teams, along with SAPS, discovered a freshly excavated illegal connection attached by unknown suspects. The fitting was removed, and the damaged section of pipeline was repaired within 24 hours. No arrests have been made.

Transnet added: "A case of tampering with essential infrastructure has been opened with the Marikana SAPS. TPL continues to work closely with law-enforcement agencies to combat fuel theft and safeguard our national infrastructure."

Fuel theft from national pipelines poses enormous risks to community safety, the environment, and the country's energy supply. Transnet has urged residents to report any suspicious digging, tanker activity, or unknown vehicles near pipeline routes.
